### **ORDINANCE NO. 1 series of 2019**

**AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 8 s.  
2017, WHICH IS KNOWN AS "TAYTAY ACCREDITATION ORDINANCE (TAO)"  
AND FOR OTHER RELATED PURPOSES**

WHEREAS, R.A. 7160, specifically Section 34 thereof, states "Local Government Units shall promote the establishment and operation of People's and Non-Governmental Organizations to become active partners in the pursuit of local autonomy;

WHEREAS, recent issuance of the Department of Local Government particularly Memorandum Circular No. 2019 - 72, has outlined the procedural guidelines on accreditation of Civil Society Organization and selection of representatives to Local Special Bodies,

WHEREAS, it is indeed necessary for the Sangguniang Bayan to simplify the accreditation process of NGOs, POs and CSO while ensuring that local policies shall always be in sync with existing national issuances;

NOW THEREFORE, be it enacted by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled that;

Section 1. Section 3.1 of Ordinance No. 8 s. 2017, is hereby amended and shall be read as follows;

3.1 Documentary Requirements

Any Taytay-based Non-Government Organization or People's Organization in active operation for at least one (1) year may be registered and accredited by the Sangguniang Bayan upon submission of, and compliance with all the following requirements:

1. Duly accomplished Letter of Application (Form 001) addressed to the Sangguniang Bayan thru the Office of the Vice-Mayor Same as a reference from the appended Annex "a" hereof A Certified true copy of the letter of application shall be furnished by the applicant to the Chairman of the Committee on Accreditation;
2. Duly accomplished Application Form for Accreditation (Form 002) same as or referenced from the appended Annex "B" hereof;
3. Board Resolution signed by the majority of the BOD's signifying intention for Municipal Accreditation;
4. Profile indicating the purpose and objective of the organization;
5. Original Certificate of Registration issued by any National Government Agency that is empowered by law or policy to accredit or register such organizations which shall be photocopied by the receiver from the Committee on Accreditation for filing. The original certificate of registration shall be returned to the organization upon securing photo copy for the Committee's files.  
Home Owners Associations and Neighborhood Associations that present SEC Registration shall not be accepted as the HLURB is the sole agency handling matters relating to home Owners Associations and Neighborhood Associations.
6. Bio-Data or Personal Data sheet of all Board of Directors/Trustees and Executive officer with 2x2 photos and a list of all current members who are residents of Taytay, Rizal;
7. Annual Accomplishment report from the preceding year signed by the President and Majority of the BOD;
8. Financial statement of the current or preceding year signed by the President, Treasurer & Auditor of the organization, indicating the total assets, capitalization and all sources of funds granted or received.

Section 2. Section 5.1 of Ordinance No. 8 s. 2017, is hereby amended and shall be read as follows;

"5.1 The effectivity of the Accreditation granted herein shall commence from the date of its approval as stated in the Accreditation Certificate issued by the Sangguniang Bayan and shall remain valid until the term of office of the Sangguniang Bayan members approving such accreditation shall have expired."

Section 3. Repealing Clause: The provision of section 3.2 of Ordinance No. 8 s. 2017, is hereby repealed accordingly


Section 4. Separability Clause: If any part of this Ordinance is declared to be invalid, the remaining part not affected by the declaration of invalidity shall remain force.

Section 5. Effectivity: This Ordinance shall take effect upon approval hereof.
