ORDINANCE NO. 5 series of 2019

AN ORDINANCE GRANTING THE APPLICATION FOR RECLASSIFICATION OF A PROPERTY APPLIED BY M & P WORLDWIDE SOLUTIONS INC., FROM RESIDENTIAL TO INDUSTRIAL 1, LOCATED AT #49 VELAZQUEZ ST., BRGY. SAN JUAN, TAYTAY, RIZAL

WHEREAS, M & P WORLDWIDE SOLUTIONS INC. applied for zoning reclassifications of a property situated at #49 Velasquez St. Brgy. San Juan Taytay, Rizal;

WHEREAS, the properties subject for reclassification has a total area of 4,704 sq. mtrs covered by Transfer Certificate Title and Tax Declaration;

WHEREAS, this grant of zoning reclassifications were based on the pertinent documents submitted by the applicant and were verified by the Municipal Assessor and Municipal Planning and Development Officer;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Bayan ng Taytay, by the power vested in it by law, in session duly assembled, that:

- Section 1. This Ordinance is enacted pursuant to the power vested upon to Sangguniang Bayan of Taytay, Rizal
- Section 2. This Ordinance is enacted relative to the application of M & P WORLDWIDE SOLUTIONS INC. to reclassify a property situated at #49 Velasquez St., Brgy. San Juan, Taytay, Rizal, from Residential to Industrial 1.
- Section 3. This Ordinance is enacted for the purpose of the following:
 - a. To guide, control and regulate the future improvement of the property of M & P WORLDWIDE SOLUTIONS INC. To promote and protect the health, safety, peace, comfort, convenience and general welfare of the residents in the nearby are of the location.
 - b. To regulate the use of machineries and infrastructure that may cause noise and air pollution in the area.
 - c. Provide an effective requirement to secure necessary license and permit to, operate.
- Section 4. This Ordinance is applicable only to TCT NO. 068-2018002216 with Tax Declaration No. 18-TY-004-24396 containing an area of 4,704 sq. mtrs.
- Section 5. That the Sangguniang Bayan ng Taytay granted this reclassification based on the pertinent documents submitted by the application and not be subject for any liability if the applicant failed to comply to the comply to the requirements of other government agencies concerned.
- Section 6. Conditions, provisions and guidelines for the improvement and development of the said properties shall be pursuant to existing local rules and regulations, and to the Building Code of the Republic of the Philippines.
- Section 7. This Ordinance shall take effect immediately upon its approval.
