**ORDINANCE NO. 8 series of 2019** 

AN ORDINANCE AMENDING THE SECTION 1 OF ORDINANCE NO. 27 SERIES OF 2003 ENTITLED: "AN ORDINANCE AMENDING ORDINANCE NO. 4 SERIES OF 1996 ENTITLED: TRAFFIC REGULATION OF THE MUNICIPALITY OF TAYTAY, RIZAL"

WHEREAS, the Sangguniang Bayan of Taytay has enacted Ordinance No. 27 on October 13, 2003, entitled "Traffic Regulations of the Municipality of Taytay, Rizal";

WHEREAS, there is a need to amend the traffic violation and penalties of said ordinance to imposed updated penalties for offenders or violators who have no qualms of violating Municipal Ordinances;

WHEREAS, with the inclusion of various Traffic Regulations under RA 4136 and other related laws, the traffic congestion and motorist discipline will be enhanced in this municipality;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled, hereby decrees of Ordinance No. 27 series of 2003 shall be amended as follows:

SECTION 1. Traffic Violations and Penalties at Taytay, Rizal.



E.) OTHER RELATED LAWS - shall be implemented accordingly.

SECTION 2. SEPARABILITY CLAUSE - If for any reason, any provision of this ordinance shall be found unconstitutional by competent authority, the other provisions not so declared to be unconstitutional shall remain valid.

SECTION 3. REPEALING CLAUSE - All Ordinance, Rule and Regulations, in parts thereof, whose provision are in conflict with, or contrary to, the Provision of this Ordinance are hereby repealed, amended or modified accordingly;

SECTION 4. EFFECTIVITY - That this Ordinance shall take effect 30 Days after posting of signages/tarpaulins in conspicuous area along the Municipality of Taytay, Rizal
