ORDINANCE NO. 9 series of 2019

APPROVING SUPPLEMENTAL BUDGET NO. 2 AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY ONE MILLION THREE HUNDRED TWENTY-THREE THOUSAND FIVE HUNDRED TWENTY-NINE PESOS AND 88 CENTAVOS (PHP21,323,529.88) FROM THE UNAPPROPRIATED BALANCE RETAINED EARNINGS FY 2018 AND THE REVERSION OF VARIOUS ACCOUNTS PAYABLE OF PREVIOUS YEARS TO FUND VARIOUS PRIORITY PROGRAMS, PROJECTS AND ACTIVITIES IN THE MUNICIPALITY

WHEREAS, various Accounts Payable items in the Financial Statement of the Municipality in the amount of PHP 11,090,700.76 which are more than 2 years and determined to be non-existent shall be reverted to the General Fund as Unappropriated Balance;

WHEREAS, Accounting Office has determined the Unappropriated Balance Retained Earnings FY 2018 which are available for Supplemental Appropriation as PHP 3,276,726.95 for General Fund and PHP 4,006,666.35 for the 20% Development Fund;

WHEREAS, various Accounts Payable items in the Financial Statement in the amount of PHP 597,208.87 pertaining to FY 2018 were recommended by the Commission of Audit for reversion as per COA AOM No. 2019-10 dated June 5, 2019;

WHEREAS, several Meralco Guaranty Deposits in the amount of PHP1,553,693.30 were refunded in the General Fund and is now available for supplemental appropriation;

WHEREAS, there are programs, projects and activities that needed funding for their immediate implementation;

WHEREAS, a supplemental budget is needed to address the various needs of the constituents in the Municipality;

NOW THEREFORE, the Sangguniang Bayan in session hereby decrees the approval of Supplemental Budget No. 2 :


