ORDINANCE NO. 11 series of 2019

**APPROVING SUPPLEMENTAL BUDGET NO. 3 AN ORDINANCE APPROPRIATING
THE AMOUNT OF FIVE MILLION SEVEN HUNDRED THIRTY THOUSAND PESOS
(PHP 5,730,000.00) FROM THE REVERSION OF VARIOUS PERSONAL SERVICES
TO FUND THE GRANT OF SERVICE RECOGNITION INCENTIVE TO LOCAL
GOVERNMENT EMPLOYEES**

WHEREAS, Administrative Order No. 19 dated December 2, 2019 by the President of the Philippines granting Service Recognition Incentive (SRI) for FY2019 was issued for implementation of all government agencies;

WHEREAS, the Local Finance Committee has identified savings from Personal Services and ensure that expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public;

WHEREAS, the Section 6 of the said Administrative Order tasked the Sangguniang Bayan to determine the grant of one-time SRI to Municipal Government Employees depending on its financial capability subject to PS limitation;

WHEREAS, there is a need for a Supplemental Budget to fund the newly introduced SRI to LGU funds;

NOW THEREFORE, the Sangguniang Bayan in session hereby decrees:

SECTION 1. The grant of a one-time Service Recognition Incentive (SRI) in the amount of PHP 10,000.00 per qualified employee in the Municipal Government of Taytay based on the provisions of Administrative Order No. 19 by the Office of the President dated December 2, 2019;






SECTION 3. That the release of the said amount shall be subject to the usual accounting and auditing rules and regulation
