**APPROVING SUPPLEMENTAL BUDGET NO. 1 AN ORDINANCE
REVERTING THE AMOUNT OF TWELVE MILLION NINE HUNDRED
SEVENTY FOUR THOUSAND FIVE HUNDRED SEVENTY SIX PESOS AND
71/100 ONLY (PHP 12,974,576.71) FROM 20% DEVELOPMENT FUND
CONTINUING APPROPRIATIONS AND GENERAL FUND THE VARIOUS
PRIORITY PROGRAMS/PROJECTS AND ACTIVITIES OF VARIOUS OFFICE
IN THE MUNICIPALITY**


SECTION 2. That the release of the said amount shall be subject to usual accounting and auditing rules and regulations.

SECTION 3. That the same rules and procedures with that of FY2019 Annual Budget shall apply in implementation of this appropriation Ordinance.


SECTION 4. That this Ordinance shall take effect upon its approval.
