## **ORDINANCE NO. 28 series of 2019**

AN ORDINANCE GRANTING THE APPLICATION FOR RECLASSIFICATION OF A PROPERTY APPLIED BY FN REALTY CORPORATION, FROM AGRICULTURAL TO INDUSTRIAL 1, LOCATED AT BRGY. SAN JUAN, TAYTAY, RIZAL

WHEREAS, FN REALTY CORPORATION applied for zoning reclassifications of a property situated in Lumang Ilog, Brgy. San Juan Taytay, Rizal;

WHEREAS, the properties subject for reclassification has a total land area of 14,125 sq.mtrs., covered by Transfer Certificate Title and Tax Declaration;

WHEREAS, this grant of zoning reclassifications were based on the pertinent documents submitted by the applicant and were verified by the Municipal Assessor and Municipal Planning and Development Officer;

NOWTHEREFORE, BE IT ORDAINED, by the Sangguniang Bayan ng Taytay, by the power vested in it by law, in session duly assembled, that:

Section1. This Ordinance is enacted pursuant to the power vested upon to

Sangguniang Bayan of Taytay, Rizal

- Section 2. This Ordinance is enacted relative to the application of FN REALTY CORPORATION to reclassify a property situated in Lumang Ilog, Brgy. San Juan, Taytay, Rizal, from Agricultural to Industrial 1.
- Section 3. This Ordinance is enacted for the purpose of the following:
  - a. To guide, control and regulate the future improvement of the property of FN REALTY CORPORATION
  - b. To promote and protect the health, safety, peace, comfort, convenience and general welfare of the residents in the nearby area of the location.
  - c. To regulate the use of machineries and infrastructure that may cause noise and air pollution in the area.
  - d. Provide an effective requirements to secure necessary license and permit to operate.
- Section 4. This Ordinance is applicable only to TCT No. 068-2019000937 with Tax Declaration No. 18-TY-004 -25422 containing an area of 14,125 sq. mtrs.
- Section 5. That the Sangguniang Bayan ng Taytay granted this reclassification based on the pertinent documents submitted by the applicant and not be subject for any liability if the applicant failed to comply to the requirements of other government agencies concerned.
- Section 6. Conditions, provisions and guidelines for the improvement and development of the said properties shall be pursuant to existing local rules and regulations, and to the Building Code of the Republic of the Philippines.
- Section 7. This Ordinance shall take effect immediately upon its approval.
