ORDINANCE NO. 15 series of 2020

AN ORDINANCE INTEGRATING AND OPERATIONALIZING THE PHILIPPINE INTEGRATED MANAGEMENT OF ACUTE MALNUTRITION (PIMAM) IN THE LOCAL HEALTH SYSTEM OF TAYTAY, RIZAL

WHEREAS, Presidential Decree No. 603 or the Child and Youth Welfare Code of the Philippines states that the child is one of the most important assets of the nation;

WHEREAS, every child has the right to the care, assistance, and protection of the State, particularly when parents or guardian are unable to provide the child with fundamental need for growth development and improvement;

WHEREAS, under the World Health Organization (WHO) threshold for Global Acute Malnutrition (GAM), the Philippines' rate of 7.3% for children under 5 years is considered poor, and the rate of 11.9% for children 6-11 months, serious;

WHEREAS, cases of Moderate Acute Malnutrition (MAM) and cases of Severe Acute Malnutrition (SAM) were identified in Taytay, Rizal;

WHEREAS, among the set nutrition targets of the Philippine Plan of Action for Nutrition 2017-2022 is the integration of the management of severe and moderate acute malnutrition in the community and health facility;

WHEREAS, the Philippines Integrated Management of Acute Malnutrition (PIMAM) is a set of updated and scientifically-proven protocols that can be used by health providers to manage acute malnutrition cases in the target age group of 6-59 months, who are the most vulnerable;

WHEREAS, PIMAM, which is community-based, is adopted from a set of international standard guidelines replacing the use of less effective methods of diagnosing and treating acute malnutrition cases;

WHEREAS, the effective implementation of PIMAM necessitates the creation of set of officer, planners, and implementers from the executive and legislative departments in the municipality to formulate the rules and regulation relative thereto;

NOW THEREFORE, be it enacted, as it is hereby enacted, by the Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

Section 1. Integration of PIMAM in the Regular Health Program: The PIMAM protocol shall be adapted and to be integrated in the Maternal and Child Health Programs of the Municipal Health Office (MHO) and become a part of the minimum service package in nutrition in all barangays.

Section 2. Role of the Municipal Health Office: The Municipal Health Office, in cooperation with the Municipal Nutrition Council – Taytay, Rizal shall lead and be responsible for the effective and efficient implementation and integration of PIMAM down to the barangay level.

Section 3. Role of Health Volunteers: The Barangay Health Workers (BHW), Barangay Nutrition Scholars (BNS), after proper training, technical input and orientation given by the Municipal Health Office, may perform the screening and detection of acute malnutrition using the weight-for-height-, Mid-Upper Arm Circumference (MUAC) and checking for nutritional edema either in the health facilities, evacuation sites or during household visits.

Section 4. Severe Acute Malnutrition (SAM): Cases without medical complication will be managed by the health team staff including Nutrition Officers, Public Health Midwives, Public Health Nurses, and District Health Officers in Barangay Health Centers and District Health Offices in an out-patient basis during the Integrated Management of Childhood Illnesses (IMCI) consultation with weekly follow-ups.

Section 5. Creation of Technical Working Group: The Technical Working Group is hereby created and shall be composed of the following;

- Head : Municipal Mayor
- Co-Head : Municipal Health Officer
- Secretariat : Municipal Nutrition Officer



Members:

- a. Councilor, *Health, Nutrition, and Sanitation Committee*
- b. Nursing Service Office of Municipal Health Office
- c. Barangay Nutrition Council Members
- d. Municipal Social Welfare and Development Office
- e. Municipal Planning and Development Office
- f. Department of Education, District Office

Section 6. Duties and Functions of the Technical Working Group: The Technical Working Group shall have the primary function of formulating the rules and regulations in the implementation and integration of the PIMAM protocol.

The Technical Working Group shall also have the duty to:

1. Conduct consultation within the group, as well as with other local and national offices, agencies, organizations or institutions, public or private, with respect to the extent, applicability, practicability, attainability, sustainability and economy of the proposed health measures;
2. Render reports, through the Secretariat, to the Office of the Municipal Mayor;
3. Submit the proposed Implementing Rules and Regulation to the Municipal Mayor for approval and/or appropriate action; and
4. To perform such order functions and do such other acts as maybe prescribed by Ordinance or by the Municipal Mayor.

Section 7. Secretariat: The Secretariat support staff shall be designated by the Municipal Health Officer, and in cooperation with the Municipal Nutrition Council, shall be responsible for the documentations of meetings and the preparation of reports and other documents as needed by the Technical Working Group. The secretariat shall keep all records, documents and reports of the group even after its dissolution, and shall furnish copies thereof to any Mayor's office of Taytay upon request.


Section 8. Budgetary Requirements and Source of Funds: The administrative and operational budgetary requirement including the recurring expenses in the implementation of this ordinance shall be charged to and included in the annual budget of the Municipal Health Office.

Section 9. Separability Clause: If, for any reason, any part or provision of this ordinance shall be held to be invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.


Section 10. Effectivity: This Ordinance shall take effect thirty (30) days upon its approval and after compliance with required posting of copies of the same conformably to the pertinent provision of Section 59 of R.A 7160.

ENACTED, this 4th day of February, 2020 at the Sangguniang Bayan Session Hall, Municipal Building, Taytay, Rizal.


