APPROVING SUPPLEMENTAL BUDGET NO. 1 AN ORDINANCE REVERTING THE AMOUNT OF TWO MILLION PESOS ONLY (P 2,000,000.00) FROM THE 20% DEVELOPMENT FUND – CONTINUING APPROPRIATIONS AND APPROPRIATING THE SAME AMOUNT FOR THE GEOGRAPHICAL INFORMATION SYSTEM (GIS) PROGRAM FOR THE MUNICIPALITY

WHEREAS, the Municipal Development Council approved the Realignment of Funds from the 20% Development Fund – Continuing Appropriations to provide additional fund for the Geographical Information System (GIS) under MDC – Executive Committee Resolution No. 2020-001;

WHEREAS, a Supplemental Budget is needed to support and appropriate the said MDC – Executive Committee Resolution No. 2020 - 001;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal in session duly assembled hereby decrees:

- Section 2. That the release of the said amount shall be subject to usual accounting and auditing rules and regulations.
- Section 3. That the same rules and procedures with that of FY 2020 Annual Budget shall apply in the implementation of this appropriation Ordinance.
 - Section 4. That this Ordinance shall take effect upon its approval.
