## **ORDINANCE NO. 18 series of 2020**

AN ORDINANCE DECLARING THE PERMANENT CLOSURE OF A PORTION OF M.C. ISON STREET, BEGINNING FROM THE CORNER OF SUMULONG STREET UP TO THE CORNER OF RIZAL AVENUE, BOUNDED BY BARANGAY DOLORES AND BARANGAY SAN ISIDRO, THIS MUNICIPALITY, AND FOR OTHER RELATED PURPOSES

WHEREAS, paramount among the thrust of the Municipal Government of Taytay, Rizal, is to ensure the delivery of basic services to its inhabitants, to include convenient and adequate access to medical care and health services;

WHEREAS, the Sangguniang Bayan of Taytay, Rizal has adopted Resolution No. 15, series of 2019, which humbly requested the Hon. Rebecca A. Ynares, Governor of Rizal Province, to construct and manage a Provincial General Hospital in the Municipality of Taytay, Rizal;

WHEREAS, only recently, the Sangguniang Panlalawigan, Province of Rizal, has adopted Resolution No. 421 s. 2019, approving the establishment of Rizal Provincial Hospital System (RPHS) Taytay Annex;

WHEREAS, Rep. Act No. 7160, otherwise known as The Local Government Code of 1991, empowered a local government unit to permanently close any local road by providing as follows;

"Section 21. Closure and Opening of Roads. (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction."

WHEREAS, based on the Cainta – Taytay Cadastre, CAD-688-D, the half portion immediately adjacent to old Municipal Building of M.C. Ison St. is within the jurisdiction of Brgy. Dolores while the other half portion immediately adjacent to the property line of Divi Mart is within the jurisdiction of Brgy. San Isidro, this Municipality;

WHEREAS, to fully comply with the required land area for the planned construction of Rizal Provincial Hospital System (RPHS), measures be adopted, by including M.C. Ison Street which is a municipal road, as part of the site for the project;

NOW THEREFORE, BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Taytay, Rizal in session duly assembled that:

- Section 1. Coverage: The municipal street, known as M.C. Ison Street, bounded by Barangay Dolores and Barangay San Isidro, this municipality, shall be closed permanently to traffic and shall cease to be part of the Municipal Street of Taytay, Rizal.
- Section 2. Usage: The street shall be utilized as part of the site for the establishment of Rizal Provincial Hospital System (RPHS) Taytay Annex.
- Section 3. Miscellaneous Provision: The adjoining municipal roads known as the Kadalagahan Street and Sumulong Street which are adjacent and connected to M.C. Ison Street shall serve as the substitute or alternate route and passageway of vehicles and passerby going to and coming from Rizal Avenue, this municipality.
- Section 4. Implementing Rules and Regulations: To effectively implement this Ordinance and to ensure provisions for public safety thereat, the Municipal Mayor shall promulgate the implementing rules and regulations for the purpose.
- Section 5. Separability Clause: If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions hereof.
- Section 6. Repealing Clause: All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed and modified accordingly.
- Section 7. Effectivity: This Ordinance shall take effect thirty (30) days upon approval and after compliance with the required posting of the same as provided for under the pertinent provision of Section 59 of Republic Act 7160.
