ORDINANCE NO. 21 series of 2020

AN ORDINANCE DECLARING B.A. CRUZ STREET WITHIN THE JURISDICTION OF TAYTAY, RIZAL, ONE WAY AND NO ENTRY

WHEREAS, pursuant to the authority vested upon Municipal Councils, by the Revised Administrative Code as amended in the Municipality;

WHEREAS, the BTMO, TMG, MPSO and TMTFRO have direct grasp on the areas to be declared as One Way and No Entry;

NOW THEREFORE, BE IT ORDAINED, by the Municipal Council of Taytay, Rizal in session assembled, that:

Section 1. Title – This ordinance shall be known as the B.A. CRUZ STREET IS ONE WAY AND NO ENTRY ORDINANCE 2020.

Section 2. Scope – This ordinance shall apply to all kinds of motor vehicles, public and private within B.A. Cruz Street from B.A. Cruz St. cor. Rizal Ave. up to B.A. Cruz St. cor. Rosario St. within jurisdiction of the Municipality of Taytay, Rizal.

Section 3. Declaration of Policy - B.A. Cruz Street is hereby declared One Way, for the vehicle coming from Barangay Sta. Ana and No Entry, for the vehicle coming from Rizal Avenue.

Section 4. Exemption – Ambulances, Fire Trucks, Police and Military Vehicles on official functions, Rescue Vehicles and Vehicles used by Medical Practitioners in an Emergency and Private Vehicles in an Emergency are exempted from this ordinance.

Section 5. Implementing Office – The Barangay Traffic Management Office (BTMO) shall be the implementing agency together with the Taytay Municipal Traffic Management Group (TMG), the Taytay Municipal Tricycle Franchising and Regulatory Office (TMTFRO), and the Municipal Public Safety Office (MPSO) for this ordinance.

Section 6. Posting – Proper posting of this ordinance and signages of One Way and No Entry at B.A. Cruz Street within the Municipality of Taytay should be observed.


Section 7. Repealing Clause – All existing ordinances inconsistent with the provisions of this ordinance are hereby repealed accordingly.

Section 8. Penalty – Violation of this ordinance or part thereof, the amended penalties shall be applied (thru TVR) on violations to restrictions stated in the ordinance base on the “Section 1. D – 66. Illegal or unauthorized counter flow of traffic – P 2,500.00” of Ordinance No. 8 series of 2019 or the traffic code.

Section 9. Effectivity – This ordinance shall take effect fifteen (15) days upon approval and after posting of signages / tarpaulins in conspicuous areas within the Municipality of Taytay.

ENACTED, this 21st day of February, 2020 at the Sangguniang Bayan Session Hall, Municipal Building, Taytay, Rizal.
