# IMPOSING A CURFEW IN THE MUNICIPALITY OF TAYTAY FOR THE PURPOSE OF CONTAINING OR MITIGATING THE SPREAD OF COVID-19 TO ITS INHABITANTS

WHEREAS, it is a declared policy in the Constitution that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, on March 8, 2020, President Duterte issued Proclamation 922 declaring a State of Public Health Emergency in the advent of the threat of the COVID-19 disease;

WHEREAS, community quarantines are now being implemented in different parts of the country in order to prevent the spread of COVID-19;

WHEREAS, the Department of Health recommended to the public to avoid unnecessary travels and to avoid crowded places in order to prevent and control the spread of the disease;

WHEREAS, the right to travel shall not be impaired except in the interest of national security, public safety, or public health, as may be provided by law;

WHEREAS, imposing a curfew at the Municipality of Taytay and restricting the movements of its inhabitants to extent allowed by law is in accord with the issuance of the President and of the Department of Health and is in the interest of public health and safety;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Taytay, Rizal in a session duly assembled that:

Section 1. Curfew Hours. - In the wake of the threat of the spread of the COVID-19 disease, non-essential movements outside the place of residence is prohibited and all person regardless of age within the Municipality of Taytay, Rizal shall not be allowed to roam in the roads, streets, plazas, parks or other public places or establishments, from 8:00 p.m. to 5:00 a.m. until the declaration of Public Health Emergency is lifted.

All Municipal and Barangay Authorities shall commence Public Address (Siren, Mobile Device such as "trompa" and the likes) at 6:00 p.m.

### **Section 2. Exemptions**: The following are hereby exempted:

- a. Health workers or providers;
- b. Municipal and Barangay Officials who are performing their responsibilities;
- c. Those who go outside to seek medical attention;
- d. Employees whose start or end of their work-shift is within the prohibited hours or those who are returning to their residence after employment;
- e. Those who are delivering or purchasing medicines and foods;
- f. Those who go outside in order to purchase or get food or other basic necessities, provided that they immediately return to their place of residence after purchasing or getting the same;
- g. Public transportation providers and personnel of public utilities;
- h. Municipal or barangay peace officers; and
- Other persons who respond or are responding to emergency situations. For this
  purpose, an emergency situation is one that involves the potential injury of any
  person or the loss of life or property.

Section 3. Authority to Ask Question. - Within the limits allowed by law, municipal, barangay and other peace officers may interrogate any person who is found outside during the prohibited hours in order to know his identity and residence, purpose of being outside and place of destination. No other information shall be required from any person.





There shall be records to be kept by Apprehending Officers to be forwarded to the Municipal Health Officer for contact tracing purposes.

Section 4. Penalties. - Any person violating this ordinance shall be imposed the following penalties shall be prosecuted in accordance with Section 9, (d) and (e) in relation to Section 10 of Republic Act No. 11332 otherwise known as the Mandatory Reporting of Notifiable Disease and Health Event of Public Concern".

In lieu of this 1<sup>st</sup> paragraph, a fine of P 1,000.00 shall be imposed to those apprehended in violation of this Ordinance.

**Section 5. Separability Clause.** - If for any reason, any provision, of this Ordinance is declared invalid by any competent court, the remaining provisions hereof shall remain in full force and effect.

**Section 6. Effectivity.** - This Ordinance shall immediately take effect until such time that the declaration of Public Health Emergency is Lifted.

ENACTED, this 16<sup>th</sup> day of March, 2020 at the Sangguniang Bayan Session Hall, Municipal Building, Taytay, Rizal.
