ORDINANCE NO. 25 series of 2020

AN ORDINANCE AMENDING THE PROVISIONS OF ORDINANCE NO. 24 S. 2020

WHEREAS, On March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, Declaring a State of Public Health Emergency throughout the Philippines;

WHEREAS, On March 15, 2020, Rizal Governor, Hon. Rebecca A. Ynares issued a Memorandum for the Temporary suspension of operation of malls, bingo and Lotto outlets, Internet Cafes, Bars, coffee shops, cockpit arenas and other places of public gatherings in the Province of Rizal;

WHEREAS, On March 16, 2020, the President thru Executive Secretary Salvador C. Medialdea issued a Memorandum regarding the declaration of Community Quarantine over the entire island of Luzon and Further Guidelines for Management of the Coronavirus Disease 2019 (COVID-19) situation;



WHEREAS, the Municipal Mayor of Taytay, Hon. George Ricardo R. Gacula II issued Executive Order Nos. 116, 117, 118 and 119 all series of 2020 in Relation to the COVID-19 Disease within the Municipality of Taytay;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Taytay, in session assembled, hereby Prescribes the Guidelines and Regulating Mobility In Taytay, Rizal During The National Public Health Emergency.

Section 1. TITLE: AMENDED PUBLIC HEALTH EMERGENCY GUIDELINE FOR TAYTAY ORDINANCE

Section 2. Food Establishments – shall be allowed to operate for take-out and delivery only from 5:00 am to 7:00 pm. Food handlers shall be required to wear protective/transport masks, gloves and hairnet at all times. All customers are highly encouraged to bring their own containers and bags for the said purpose. All establishments shall provide queues/lines that practice strict social distancing from the entrance up to the payment area.

Section 3. Transportation 3.1 for tricycles flat rate of 25.00 pesos per passenger for point to point trips shall be allowed. Only one passenger shall be allowed to ride per trip. No back rider will be allowed. Tricycles shall be allowed to operate within Taytay only from 5:00 am to 8:00 pm. Color coding shall still be implemented during this period. All drivers are required to wear masks at all times and observe social distancing and proper hygiene.

3.2 Tricycles shall be allowed to service patients to and from medical facilities provided that the driver shall have the Home Quarantine Pass letting him at all times.

Section 4. Dry Goods Stores / Supermarkets / Groceries / Sari-Sari Stores / Convenience Stores – shall be allowed to operate from 6:00 am to 8:00 pm provided social Distancing is observed at all times especially when queuing for payment. Senior Citizens/PWD's/and priority lanes shall be present in all stores following the provisions of existing laws. All establishments shall provide queues/lines that practice strict social distancing from the entrance up to the payment area.

Section 5. Drug Stores/Pharmacies – shall be allowed to operate on extended hours provided that only the pharmacy section shall be operational. Groceries part of the drugstores shall follow the provisions of Section 4 at this ordinance. All establishments shall provide queues/lines that practice strict social distancing from the entrance up to the payment area.

Section 6. Gatherings – All forms of gambling shall be prohibited specially in wakes. Visiting wakes shall be encouraged to be until 7:00 pm only. All sports activities and leagues shall be suspended. All multi-purpose gyms and courts shall be closed for public gatherings and any sports activities. All common religious congregations shall be discouraged to avoid the spread of the virus. All festivities and traditional acts such as Senakulo, Penitensya and the likes are likewise prohibited.

Section 7. Total Liquor Ban - The sale of all types of alcoholic drinks shall be prohibited until the National Health Emergency is lifted. Signage of the liquor ban shall be posted in selling areas of the stores. Consuming of any Alcoholic drinks in public places is hereby prohibited.

Section 8. Videoke Rental – The rent/lease of Videoke machines shall be prohibited to avoid the spreading of disease/virus thru the use of communal microphones.

Section 9. New Taytay Public Market/Old Market/All Talipapas – shall be in operation from 5:00 AM up to 7:00 PM. All personnel assigned to the NTPM/EEDM shall regularly monitor that social distancing is being strictly observed by all market goers and vendors at all times. Dealers shall be allowed to deliver goods and commodities at the Public Market. There shall be a 5PM cut off for consumer that no pass, no buy policy shall be observed by the sellers. All establishments

shall provide queues/lines that practice strict social distancing from the entrance up to the payment area.

- Section 10. Ambulant Vendors/Sidewalk Vendors shall be prohibited across the municipality at all times.
- Section 11. Tiangge All Tiangge operations shall be temporarily prohibited until such time that the State of Public Health Emergency is lifted.
- Section 12. Waste Segregation. All households are mandated to observe proper waste segregation and waste disposal as the hauling and collection of garbage is currently hampered by the current community quarantine from adjacent areas.
- Section 13. Senior Citizens All Senior Citizens are extremely discouraged from going out of their houses to purchase goods, medicines and the likes as the records around the world have shown that the elderly are the most vulnerable and at the highest risk of contracting the COVID-19 virus.
- Section 14. Home Quarantine Pass- Since the imposition of the Extreme Enhanced Community Quarantine, the Barangays have issued a Home Quarantine Pass for every household. No person shall be allowed to go out of their homes and shall not be allowed to purchase any goods without presenting their Home Quarantine Pass. The Home Quarantine Pass is free of charge and shall not be sold. Violators will be dealt with accordingly.
- Section 15. Shuttle Service The Local Government Unit of Taytay shall provide free shuttle services within the bounds of Taytay for MEDICAL HEALTH WORKERS ONLY who will be reporting for work and going home. The official company ID of the MEDICAL HEALTH WORKERS shall be presented to the shuttle service provider to be allowed access to the service.
- Section 16. Motorcycle Back riders Back riders shall only be allowed for MEDICAL HEALTH WORKERS reporting for work and going home provided that the driver has the Home Quarantine Pass present at all times. The official company ID of the MEDICAL HEALTH WORKERS shall be worn at all times.
- Section 17. Closure of Roads The Municipal Mayor is authorized to issue closure of roads, if necessary, as a preventive measure for the spread of the COVID-19 virus.
- Section 18. Monitoring and Implementation. The Local Government Unit of Taytay and all Barangay Local Government Units shall monitor and implement the provisions of this ordinance. They shall strictly monitor that all establishments are providing queues/lines that practice strict social distancing from the entrance up to the payment area.
- Section 19. Penalty Clause A fine of P2,500.00 shall be imposed for every violation of the provisions of this ordinance. Subsequent/habitual violations may lead to the revocation of Business Permits and Closure of establishments concerned, likewise, failure to comply with the no Home Quarantine Pass, no selling shall result in the same.
- Section 20. Information Dissemination The Public Information Office of this Municipality and the Barangay shall spearhead the information dissemination of this ordinance.
- Official details regarding COVID-19 updates from the municipality shall come from official memorandum issued by Municipal Health Office and posted at the official page of the Taytay Public Information Office.
- Section 21. Separability Clause- If any provision of this ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 22. Effectivity Clause – This ordinance shall take effect immediately and upon posting in all Barangay offices. This Ordinance shall likewise in effect until such time that the National Health Emergency is lifted.

Section 23. Colatilla – Policies shall be stricter from time to time as the need arises. All statutes and policies by the Local Government Unit of Taytay shall be on a day to day basis based on the pronouncements of National Government Agencies or higher offices

ENACTED, this 24^a day of March, 2020 at the Sangguniang Bayan Session Hall, Municipal Building, Taytay, Rizal.
