ORDINANCE NO. 28 series of 2020

**APPROVING SUPPLEMENTAL BUDGET NO. 2 AN ORDINANCE
APPROPRIATING THE AMOUNT OF FIFTY TWO MILLION SIX HUNDRED
EIGHTY THOUSAND TWO HUNDRED NINETY-FIVE PESOS (PHP
52,680,295.00) FROM THE BAYANIHAN GRANT TO CITIES AND
MUNICIPALITIES PROGRAM OF THE NATIONAL GOVERNMENT TO A
SPECIAL ACCOUNT UNDER THE GENERAL FUND TO BE CREATED AS
BGCM (BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES)
INTENDED FOR COVID-19 RELATED PROGRAMS, PROJECTS AND
ACTIVITIES OF THE MUNICIPALITY**

WHEREAS, the National Government thru the Bayanihan Grant to Cities and Municipalities (BGCM) has allocated the amount of Php 52,680,295.00 for the Municipality of Taytay;

WHEREAS, Local Budget Circular No. 125 dated April 7, 2020 of Department of Budget and Management was issued to provide guidelines on the release and utilization of the said BGCM;

WHEREAS, the Department of Interior and Local Government and Department of Budget and Management under their Joint Memorandum Circular No. 02 dated March 30, 2020 have authorized the deferment of the approval of supplemental AIP for COVID-19 related PPAs by the Municipal Development Council and Sanggunian at a later date until the situation normalize;

WHEREAS, there is a need for an immediate Supplemental Budget to address the needs of the COVID-19 related PPAs of the Municipality;

NOW THEREFORE, the Sangguniang Bayan of Taytay, in session duly assembled hereby decrees:

Section 1. Approve the deferment of the approval of Supplemental AIP of this Supplemental Budget by the Municipal Development Council and this Sangguniang Bayan at a later date when the situation normalizes as guided by DILG DBM JMC No. 02 dated March 30, 2020.

Section 2. A Special Account under the General Fund to be named as BGCM (Bayanihan Grant to Cities and Municipalities) is hereby Created to conform with the provision of Section 3.7 of DBM Local Budget Circular No. 125 dated April 7, 2020. The said fund shall be under the direct responsibility of the Office of the Mayor.

Section 3. The approved Appropriation to wit:

Section 4. The utilization of this BGCM shall be subject to the usual local budgeting process pursuant to the pertinent provisions of the Local Government Code of 1991 as guided by DBM LBC No. 125 dated April 7, 2020.

Section 5. Disbursement and utilization of this BGCM shall be subject to the pertinent provisions of Government Procurement Reform Act (RA9184) and its IRR and any relevant policies issued by Government Procurement Policy Board (GPBB) as well as other applicable laws, budgeting, accounting and auditing rules and regulations.


Section 6. In accordance with Section 336 of RA7160, the Honorable Mayor is authorized to augment items within this BGCM specifically for COVID-19 related PPAs only as guided by DBM LBC No. 125 dated April 7, 2020.

Section 7. The Sangguniang Bayan shall be furnished a copy of the monthly report that is mandatory based on Section 4.2 and 4.3 of the Posting and Reporting Requirements part of the DBM Local Budget Circular No. 125 dated April 7, 2020.

Section 8. That this Ordinance shall take effect upon its approval.
