ORDINANCE NO. 29 s. 2020

**APPROVING SUPPLEMENTAL BUDGET NO. 3 AN ORDINANCE REVERTING
SEVERAL PROJECTS UNDER THE 20% DEVELOPMENT FUND AMOUNTING TO
THIRTYONE MILLION FOUR HUNDRED FIVE THOUSAND FIVE HUNDRED
TWENTYFIVE PESOS AND 65/100 (PHP 31,405,525.65) AND APPROPRIATING THE
SAME TO VARIOUS ACCOUNTS FOR COVID 19 RELATED PROGRAMS,
PROJECTS AND ACTIVITIES IN THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, the President has declared the whole Nation under the State of Calamity under Presidential Proclamation No. 929 s. 2020 due to the spread of Covid 19 and said condition is expected to stay in the next several months;

WHEREAS, the Municipality has used up its Quick Response Fund of its MDRRM Fund as well as the MDRRM Trust Fund, and will continue to need additional fund for PPA's related to Covid 19;

WHEREAS, the Department of Interior and Local Government and Department of Budget and Management under their Joint Memorandum Circular No. 02 dated March 30, 2020 have authorized the deferment of the approval of supplemental AIP for Covid 19 related PPA's by the Municipal Development Council and Sanggunian at a later date until the situation normalize;

WHEREAS, the DILG and DBM under their Joint Memorandum Circular No. 01 dated 27 March 2020 has issued Additional Guidelines on the Utilization of the 20% Development Fund in view of the Coronavirus Disease 2019 (Covid19) situation;

WHEREAS, MDC Executive Committee Resolution No. 2020-003 authorizes the reversion of several projects amounting to PHP 31,405,525.65 to address the need for Covid 19 related PPA's;

WHEREAS, there is a need for a Supplemental Budget to address the concern of MDC Execom to authorize the implementation of the concerned PPA's;

NOW THEREFORE, the Sangguniang Bayan of Taytay in session duly assembled hereby decrees;


SECTION 5. That the same rules and procedures with that of the FY2020 Annual Budget shall apply in the implementation of this appropriation ordinance.


SECTION 7. That this Ordinance shall take effect upon its approval.
