ORDINANCE NO. 31 series of 2020

AN ORDINANCE MANDATING THE PLACEMENT OF MEASURES FOR STRICT IMPLEMENTATION OF PHYSICAL / SOCIAL DISTANCING OF PEOPLE IN ALL ESTABLISHMENTS IN TAYTAY, RIZAL TO CURB THE SPREAD OF COVID-19

WHEREAS, Republic Act No. 11469 also known as the Bayanihan to Heal As One Act declares the existence of a National Health Emergency arising from the Coronavirus Disease 2019 (COVID-19) situation;

WHEREAS, social distancing has been a proven method of preventing close contact between individuals that may transmit viruses or diseases to each other thus hampering the possible spread of the Corona virus disease;





WHEREAS, with the transition to General Community Quarantine of this Municipality and later on moving towards the "New Normal" phase, it is but fitting to place necessary measures that will instill in the people conscious effort to observe physical distancing at all times;

WHEREAS, the Local Government Unit of Taytay promulgates measures to help curb the spread of the disease, in one way, by establishing physical distancing practices throughout the Municipality;

NOW THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, that:

Section 1. Social Distancing / Physical Distancing of at least one (1) meter or at least three (3) feet radius from person to person shall be strictly observed at all times in all public places and all establishments whether private or public that are allowed to operate under any Community Quarantine.

Section 2. Visible Designated Floor Markings on all government, public and private establishments allowed to operate during Community Quarantine should be placed on all queues / lines indicating where the person should be waiting while in line waiting for their turn to be served. These queue / line floor markings should be easily noticeable and should measure at least three (3) feet apart. This shall be placed inside and outside the premises where people or customers would line up. The owners of the allowed establishments are mandated to place such markings and signages that informs that social distancing shall be strictly observed at all times.

These markings can be in a form of a Line, a Box, a Circle or any shape or logo that will serve as a visual cue where people will be standing on while falling in line.

Small establishments such as Sari-sari Stores that do not have enough spaces for queueing shall display signages that calls for the strict observation of physical distancing for all customers.

- **Section 3.** Entry and Exit points should observe physical / social distancing at all times. Separate Entrances and Exits are implored as well as the adherence to One Way flow of foot traffic of people plying the establishments allowed to operate during Community Quarantine.
- Section 4. Offices, Manufacturing Establishments, Production lines and Official Meetings allowed during Community Quarantine should have their tables placed at least three (3) feet away from each other.
- Section 5. Relief Operations and all forms of Charity Works shall strictly observe physical / social distancing between givers and receivers and among recipients. When a queue / line is inevitable, a distance of one (1) meter or three (3) feet between a person and another individual must be observed at all times.
- **Section 6. Persons Responsible** the Owner, the Management, any Officer-in-Charge or Organizers shall assign enough personnel to ensure that proper social / physical distancing is being observed at all times.
- Section 7. Penalty A fine of ₱ 2,500.00 shall be imposed or community service of six (6) hours for individual for every violation of the provisions of this ordinance. Subsequent/habitual violations may lead to the revocation of Business Permits (for business establishments) and Closure of establishment concerned.
- Section 8. Implementing Arm Members of the PNP, MPSO, GSO, BPLO, Barangay Officials and Barangay Peacekeeping Teams and other Municipal Officials to be determined by the Municipal Mayor shall implement the provisions of this Ordinance.

- **Section 9. Separability Clause** If any provision of this ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.
- **Section 10.** Repealing Clause All existing ordinances, resolutions, rules and regulations, or parts thereof, in conflict with or inconsistent with any provisions of this Ordinance are hereby repealed, amended or modified accordingly.
- Section 11. Effectivity This ordinance shall take effect immediately until such time that the Community Quarantine is lifted.
