ORDINANCE NO. 35 series of 2020

AN ORDINANCE PRESCRIBING THE GUIDELINES FOR BUSINESS ESTABLISHMENTS OFFERING DINE- IN SERVICES IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL BASED ON MINIMUM HEALTH PROTOCOLS REQUIRED BY THE NATIONAL AGENCIES DURING THE DECLARATION OF GENERAL COMMUNITY QUARANTINE

WHEREAS, the Inter Agency Task Force (IATF) for the management of emerging infectious disease issued the Omnibus Guidelines on the implementation of community quarantine prescribing the minimum health standard to be followed during the occurrence of the COVID-19 Pandemic, among the latest the IATF adopted Resolution 45 dated June 10, series of 2020 which approves the recommendation of Department of Trade and Industry (DTI) on the proposed protocols for the re-opening of dine-in food establishments;

WHEREAS, other related national agencies like the Department of Tourism (DOT) and the Department of Labor and Industry (DOLE) releases executive and administrative orders to support the said intention on the sectors they represent;

WHEREAS, there is a need to legislate an ordinance to localize the guidelines set by the national government in order to ensure alignment with its policies and objectives in the local government unit;

NOW THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay in session duly assembled hereby decrees that:

SECTION 1 - TITLE - PRESCRIBING GUIDELINES FOR BUSINESS ESTABLISHMENTS OFFERING DINE-IN SERVICES

SECTION 2 - RATIONALE – The proper health protocol shall be observed in every establishments re-opening their dine- in services to assure the public that the intention will not further spread the viral disease and protects the health condition of the community during the quarantine period.

SECTION 3 – COVERAGE – All business establishments re-opening the dine-in services:

- a) **Restaurants inside big hotel/resort** – guided by the protocol issued by the Department of Tourism, Department of Labor and Employment and IATF.
- b) **Restaurant, Fast Food, Coffee Shop and likes** – guided by the protocol issued by the Department of Trade and Industry, Department of Labor and Employment, Local Ordinance of the municipality and IATF.
- c) **Food establishments, Eateries, Carinderia, Lomi House, Ihaw-ihaw, Pansitan and the likes** - guided by the protocol issued by the Department of Trade and Industry, Local Ordinance of the Municipality and IATF.
- d) **Restaurants offering buffet services** are not yet allowed to operate.
- e) **Ambulant food vendors, side-walk vendors** are not allowed/encourage to provide dine-in services in the streets.
- f) **Barbecue, Hepa-log and fish-ball Vendors** are for take-out option only, sauces had to be packed, common big bottles for dipping sauces are not allowed.

SECTION 4 - REQUIREMENTS TO COMPLY BEFORE RE-OPENING

Starting June 15, 2020, a LETTER OF INTENT to re: open the Dine- in services had to be filed In the Office of the Mayor in the municipality. Inspection will be conducted by the Municipal Health Office and the Business Permit and Licensing Office on the compliance of the required health protocol guided by the issuances made by the national agency in-charge per sectors they represent. A recommendation certifying compliance will be submitted to the Local IATF of the municipality headed by the Municipal Mayor as basis for the approval of the said request to re- open the dine- in services in the establishments.

SECTION 5- LOCALLY IMPOSED HEALTH PROTOCOL

- a) **For Restaurant, Fast Food, Coffee Shop and likes** - guided by the protocol issued by Department of Trade and Industry, Department of Labor and Employment Local Ordinance of the municipality and IATF.

The establishments shall operate;

- Operate on 30 % capacity
- With workers using facemask or face-shield, apron or gloves
- With workers and customers observing social distancing- queue signs/arrow on the dine-in and kitchen area had to be visible.
- With Sterilization processing of utensils, a must for every use - (disposables one-time use) as an option required.
- With workers assigned in one area only per shift;
 - if cashier- cashier only,
 - if server- server only,
 - if workers in the kitchen- in the kitchen only.
- Water Dispenser for Drinking is not encouraged instead bottled mineral water is an option to consider
- With safety hygiene protocol strictly observed inside the premises.
- The customers can bring their own eating utensils in the dine-in area as an option.



- b) Food establishments, Eateries, Carinderia, Lomi House, Ihaw-ihaw, Pansitan and the like - guided by the protocol issued by the Department of Trade and Industry, Local Ordinance of the municipality and IATF.

The establishments shall operate;

- On limited capacity
- With workers using facemask or face-shield, apron and gloves
- With workers and customers observing social distancing- queue signs/arrow on the dine-in and kitchen area had to be visible.
- With Sterilization processing of utensils, a must for every use - (disposables one-time use) as an option required.
- With workers assigned in one area only per shift;
 - if cashier- cashier only,
 - if server- server only,
 - if workers in the kitchen- in the kitchen only.
- Water Dispenser for Drinking is not encouraged instead bottled mineral water is an option to consider
- With safety hygiene protocol strictly observed inside the premises.
- The customer can bring their own eating utensils in the dine-in area



SECTION 6 - ELDERLY AND YOUTH –Any person below twenty-one (21) years old and those who are sixty years old and above, are not allowed to enter establishments offering dine-in services.

SECTION 7 - MONITORING AND IMPLEMENTATION – The Municipal Health Office and the Business Permit and License Section will be the inspecting team to monitor the implementation of the stated requirements, rules and regulations.

SECTION 8 - PENALTIES – Violators of the provision of this ordinance shall be dealt accordingly:



- a) First Offense - a communication will be sent to the establishments stating the violation incurred and the Warning that if not properly corrected will mean closure of the establishment.
- b) Second Offense- a fine of P2,500.00 and Closure of the establishments.


SECTION 9 - INFORMATION DISSEMINATION – The Public Information Office and the Barangay concerned of this municipality shall spearhead the information dissemination of this ordinance and posted at the official page of the Taytay Public Information Office.

SECTION 10 - EFFECTIVITY CLAUSE – This ordinance shall take effect immediately upon approval. This ordinance shall be likewise in effect until such time that the National Health emergency is lifted.

SECTION 11- COLATILLA – Policies maybe stricter from time to time or may ease as the need arises. All statutes and policies by the Local Government Unit of Taytay shall be on day to day basis based on the pronouncements of the National Government Agencies or Higher Offices.
