ORDINANCE NO. 36 series of 2020

**AN ORDINANCE PRESCRIBING GUIDELINES ON THE TEMPORARY USE OF THE
3RD FLOOR OF THE NEW TAYTAY PUBLIC MARKET IN FAVOR OF THE
DESIGNER AND EVENTS ORGANIZER AND OTHER BUSINESS ENTHUSIAST,
THEREBY SUSPENDING SECTION 4 OF THE TAYTAY PUBLIC MARKET CODE
FOR THIS PURPOSE**

WHEREAS, the situation brought by the Covid-19 Pandemic nowadays had affected drastically the Tourism Industry of which the Designers and Event Organizers Industry relied their operation and businesses affiliation and connections for purposes of sale or income, thus the change humbled them to seek the help and support of the government agencies;

WHEREAS, the Designers and Event Organizers sector in the Municipality of Taytay verbalizes their collective request to the Local Government Officials for a chance to use the space in the third floor of the Public Market as their showroom, display center and outlet of product during the quarantine time, sparing them of huge rental expenses;

WHEREAS, in the effort to help the business sectors on this trying times, the Municipal Government of Taytay readily offered a hand and favored the request on the temporary use of the space at a minimal rate, for at least six (6) months to help them overcome the continuous loss and help them gradually get back to business as the situation eases from quarantine to a new normal set-up;

NOW THEREFORE be it ordained by the 11th Sangguniang Bayan in session duly assembled hereby decrees that:

SECTION 1 – That, Section 4 of Ordinance on Market Code 2019 be suspended momentarily, at least for a period of six (6) months from July to Dec. 2020, for this purpose;

That, instead of the amount stated in the Market Code as rental fee, a minimum fee of 100.00 per day per 2x2 square meters space will be collected to them starting on operation day (July to Dec. 2020). Payments will be collected by the Market Collector and endorsed to the Office of the Municipal Treasurer.

SECTION 2- That, whatever improvements to be made shall be course through and under the approval of the Office of the Public Market and Municipal Engineering Office.

SECTION 3 – That, the Business Operating time will be same with the Market Operating time, observing the curfew hours prevailing during quarantine period.


SECTION 4 – That, the registered and legitimate Designers and Event Organizers of the municipality will be the priority of this grant.

SECTION 5 - That, in case other interested sectors in the municipality wants to occupy the remaining space in the said building it will be subject to the approval of the Office of the Public Market under the guidance of the Committee on Market, Slaughterhouse and Economic Enterprise.

SECTION 6- Effectivity Clause – That this ordinance shall take effect immediately upon approval.
