ORDINANCE NO. 37 series of 2020

AN ORDINANCE GRANTING AMNESTY ON MONTHLY RENTAL FEE OF THE STALLHOLDERS OF TAYTAY PUBLIC MARKET

WHEREAS, the Covid-19 Pandemic had affected the local trade and transactions in the Public Market as the main source of products and staple food in the locality, the several health protocol like color coding, temperature checking and lining-up before entry added to the dropped in the numbers of market goers which affected the sales of stall holders in the Public Market;

WHEREAS, some national government agencies and other private agencies had extended financial grant, exemptions and other relief in payment assistance to their client, customers and beneficiaries;

WHEREAS, it is just proper and appropriate that the Local Government extends a helping hand for this purpose to all stall holders so that they can in return recover from the loss incurred in sales they had been experiencing since first quarter of the year;

NOW THEREFORE be it ordained by the 11th Sangguniang Bayan in session duly assembled hereby decrees that:


SECTION 1 - All Stallholders in Building A, B, C shall be granted an amnesty in payment of monthly rental fee for the month of March and April, 2020.

SECTION 2 - In case payments had been made, said payments shall be charge to the next preceding month or as an advance payment as the case maybe.

SECTION 3 - Copies of this ordinance shall be sent to the Taytay Public Market Office, Municipal Treasurers Office for their appropriate action and consideration.
