ORDINANCE NO. 38 series of 2020

**AN ORDINANCE MANDATING BUSINESS ESTABLISHMENTS TO REGISTER ALL
VISITORS AND OTHER LOCAL TOURIST AS THEY ENTER THE
ESTABLISHMENTS FOR PURPOSES OF CONTACT TRACING RELATIVE TO THE
CONTINUOUS EFFORT OF THE MUNICIPALITY ON THE CONTROL OF SPREAD
OF COVID- 19**

WHEREAS, the Inter Agency Task Force (IATF) for the management of emerging infectious disease had amended the Omnibus Guidelines on the implementation of community quarantine in the Philippines as of June, 03, 2020;

WHEREAS, the amendments made were in consideration of the recommendations from the different government agencies aiming to provide a more relaxed quarantine conditions on

selected areas without undermining the possibilities of an increase of cases once unable to provide necessary safeguard on the health condition and practices of a certain community;

WHEREAS, in the collective effort of the national government to face the challenges of the Covid- 19 Pandemic, the local government units were encouraged to provide local laws supporting the same mission;

NOW THEREFORE be it ordained by the 11th Sangguniang Bayan in session duly assembled hereby decrees that:

SECTION 1 – TITLE – REQUIRING REGISTRATION OF ALL VISITORS AND TOURIST ENTERING BUSINESS ESTABLISHMENTS WITHIN THE MUNICIPALITY OF TAYTAY FOR PURPOSES OF CONTACT TRACING

SECTION 2 - RATIONALE –To be able to safeguard the health condition of the locals in the municipality, a protocol shall be established to ease the contact tracing of all visitors and tourist entering the business establishments in the municipality. Therefore, the need to Register-to document and master list all the visitors and Local Tourist for possible contact tracing later on if the need arises, will be an added law if enacted, to social distancing and wearing of face mask to control the spread of Covid- 19.

SECTION 3 – DEFINITION OF TERMS

- a) **Visitors and Tourist** – for purposes of this ordinance, are the non- residents of Taytay doing transactions either business or personal use in all business establishments, more particularly in Tiangge Cluster stalls / Garments Sections.
- b) **Tiangge in Taytay** – Cluster of stalls located within and around the Club Manila East Areas selling products made by Taytayeño.
- c) **Contact Tracing Procedure** – for purposes of this ordinance – the act of enlisting by registration the visitors and tourists entering business establishment in the municipality, to be able to document for purposes of tracing back their whereabouts if the health need arises.
- d) **Business Establishments** –for the purpose of this ordinance, the Tiangge Stalls, Malls, Car Dealers Showroom, Hotels, Resort, Restaurants and Government facilities.

SECTION 4 – REGISTRATION – It shall be strictly required to register all visitors and local tourist entering the business establishment like Tiangge Clustered Stalls, Malls, Food Establishments, Car Showroom, Hotel, Resort, Restaurant and Government facilities and the likes.

In Restaurants upon entry, the management will be the one who will register the guest.
Tiangge Clustered Stalls – they need to register in every garments section.
No registration, No entry.

SECTION 5- MONITORING AND IMPLEMENTATION – The Municipal Tourism Office, Municipal Health Office, Business Permit and License Section and the Municipal Public Safety Office shall form a working team that will prepare the best procedure adaptable to the situation, to be able to conduct a detailed but short and smooth registration procedure of visitors, local tourist and business enthusiasts entering a business establishment premises. The said offices will also designate the group in-charge on the registration in every establishment.

SECTION 6- PENALTIES – Violators of the provision of this ordinance shall be dealt accordingly:

Visitors and Local Tourist who refuse to register shall be denied entry to the business establishments.

Visitors and Local Tourist shall present valid identification card to support the data's they had lodged in the information sheet.

Falsification of data lodged in the information sheet will be fine accordingly.

A fine of Two Thousand Five Hundred Pesos (P2500.00) and or (24) hours Community Service.

Failure to register will be fine accordingly.

A fine of Two Thousand Five Hundred Pesos (P2500.00) and or (24) hours Community Service.


SECTION 7- INFORMATION DISSEMINATION – The Public Information Office and the Barangay concerned of this municipality shall spearhead the information dissemination of this ordinance and posted at the official page of the Taytay Public Information Office.

SECTION 8- EFFECTIVITY CLAUSE – This ordinance shall take effect immediately upon approval. This ordinance shall be likewise be in effect until such time that the National Health emergency is lifted.

SECTION 9- COLATILLA – Policies maybe stricter from time to time or may ease as the need arises. All statutes and policies by the Local Government Unit of Taytay shall be on day to day basis based on the pronouncements of the National Government Agencies or Higher Offices.


