ORDINANCE NO. 42 series of 2020

APPROVING SUPPLEMENTAL BUDGET NO. 4 AN ORDINANCE REVERTING THE AMOUNT OF TWENTY FOUR MILLION THREE HUNDRED SEVENTEEN THOUSAND NINETY ONE PESOS AND 29/100 (PHP 24,317,091.29) FROM VARIOUS BUDGETARY ACCOUNTS IN THE MUNICIPALITY FOR FY 2020 AND APPROPRIATING THE SAME AMOUNT TO VARIOUS EXPENDITURE ITEMS FOR THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the President has declared the whole Nation under the State of Calamity under Presidential Proclamation No. 929 s. 2020 due to the spread of COVID-19 and said condition is expected to stay in the next several months;

WHEREAS, the DILG and DBM under their Joint Memorandum Circular No. 01 dated 27 March 2020 has issued Additional Guidelines on the Utilization of the 20% Development Fund in view of the Coronavirus Disease 2019 (COVID-19) situation;



WHEREAS, MDC Resolution No. 2020-005 authorizes the reversion of several projects amounting to PHP 10,543,091.29 to address the need for COVID-19 related PPA's;

WHEREAS, the Department of Budget and Management (DBM) has issued Budget Circular 2020 – 1 dated March 24, 2020 providing Guidelines on the Grant of the COVID-19 Hazard Pay to qualified Government Workers during the Enhanced Community Quarantine Period;

WHEREAS, the DBM has also issued Budget Circular 2020 – 2 dated April 7, 2020 providing Guidelines on the Grant of Special Risk Allowance to Frontline Public Health Workers during the Enhanced Community Quarantine Period relative to the COVID-19 Outbreak;

WHEREAS, there is a need for a Supplemental Budget to address the concern of MDC to authorize the implementation of the concerned PPAs as well as to grant the Hazard Pay and Special Risk Allowance to qualified LGU employees;

NOW THEREFORE, the Sangguniang Bayan of Taytay in session duly assembled hereby decrees;

SECTION 1. Authorizing the Grant of PHP 200.00 per day Hazard Pay to all qualified LGU employees as guided by Budget Circular No. 2020 – 01 dated March 24, 2020 for the duration of the Enhanced Community Quarantine Period in the Municipality of Taytay.

SECTION 2. Authorizing the Grant of a one-time Special Risk Allowance at rates determined by Budget Circular No. 2020-02 dated April 7, 2020 to all qualified Public Health Workers during the implementation of the Enhanced Community Quarantine in the Municipality of Taytay.

SECTION 6. That the grant of Hazard Pay and Special Risk Allowance in this Supplemental Budget shall be in accordance with the provisions of DBM Budget Circular Nos. 2020 – 1 and 2020 – 2 respectively.



SECTION 7. That the same rules and procedures with that of the FY 2020 Annual Budget shall apply in the implementation of this appropriation ordinance.

SECTION 8. That this Ordinance shall take effect upon its approval.
