ORDINANCE NO. 45 series of 2020

AN ORDINANCE PROVIDING FOR STIFFER PENALTY ON SOME ENACTED COVID-RELATED ORDINANCES OF THE MUNICIPALITY AMENDING FOR THIS PURPOSE THE RESPECTIVE PENALTY CLAUSE PROVISIONS THEREFORE AND FOR OTHER RELATED PURPOSES

WHEREAS, the Dept. of Interior and Local Government (DILG) had issued a Memorandum dated July 23, 2020 to all Local Sanggunian, among others regarding Enactment and Amendment of existing local Ordinances to include provision of penalty for the people to strengthen implementation of quarantine and health safety standard protocols to contain COVID-19:

WHEREAS, as stated in Res. 60-A dated July 30, 2020 of the IATF (5) (ii) a stringent enforcement of minimum health standard was mandated in Local Government Unit of National Capital Region and some areas in Region IV-A, including Rizal Province;



WHEREAS, the 11th Sangguniang Bayan of Taytay in compliance of the directive of the Department of Interior and Local Government (DILG) hereby amends the penal provisions of the Ordinances related to Covid-19;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the 11th Sangguniang Bayan of Taytay, in session duly assembled, that:

SECTION 1 - TITLE: PROVIDING STIFFER PENALTY ON SOME ENACTED COVID-RELATED ORDINANCES OF THE MUNICIPALITY.

SECTION 2 - COVERAGE: All the stated below ordinances relative to covid-19.

SECTION 3 - AMENDMENTS

A. Penalty Clauses

1. Ordinance No. 23, series of 2020

Section 4. Penalty Clause will be amended as:

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

2. Ordinance No. 25, series of 2020

Section 19. Penalty Clause will be amended as:

Individual:

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

Establishments:

Subsequent / Habitual Violations may lead to Closure of establishments concerned to a maximum of three (3) days and revocation of Business Permit, <u>likewise</u>, <u>failure to comply with the "No Home Quarantine Pass / COVID-19 Zoning and Household Pass</u>, No selling" shall result in the same.

3. Ordinance No. 26, series of 2020

Section 4. Penalty will be amended as:

Ordinance No. 45 Series of 2020 Page 2 of 5 pages Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

4. Ordinance No. 27, series of 2020

Section 5. Penalty will be amended as:

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

5. Ordinance No. 31, series of 2020

Section 7- Penalty will be amended as:

Individual:

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

Establishments:

Subsequent / Habitual Violations may lead to Closure of establishments concerned to a maximum of three (3) days and revocation of Business Permit.

6. Ordinance No. 32, series of 2020

Section 4 - Penalties will be amended as:

First Offense: Reprimand and confiscation of the kite, strings and other materials.

Second Offense - Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

If the violator is a minor, the parents or legal guardian shall be penalized according to the provision of Section 4 of this Ordinance.

7. Ordinance No. 33, series of 2020

Section 19 – Penalty will be amended as:

Individual:

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

Establishments:

Subsequent / Habitual Violations may lead to Closure of establishments concerned to a maximum of three (3) days and revocation of Business Permit, <u>likewise</u>, <u>failure to comply with the "No Home Quarantine Pass / COVID-19 Zoning and Household Pass</u>, <u>No selling" shall result in the same</u>.

8. Ordinance No. 35, series of 2020

Section 8 will be amended as:

Establishments:

a) First Offense - a communication will be sent to the establishments stating the violation incurred and the warning that if not properly corrected will mean closure of the establishment.



b) Second Offense – a fine of 2,500 and Closure of establishments to a maximum of three (3) days.

9. Ordinance No. 38, series of 2020

Section 6 - Penalties shall be amended as:

Individual:

Visitors and Local Tourist who refuse to register shall be denied entry to the business establishments.

Visitors and Local Tourist shall present valid identification card to support the data's they had lodged in the information sheet.

Falsification of the data lodged in the information sheet will be fine accordingly.

Failure to register will fine accordingly and who refuse to register shall be denied entry to the business establishments.

Fine ranging from 1,000 to P2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court.

Establishments:

Subsequent / Habitual Violations may lead to Closure of establishments to a maximum of three (3) days and revocation of Business Permit.

B. Effectivity Clause

1. Ordinance No. 25, series of 2020

Section 22 - Effectivity Clause will be amended as:

This ordinance shall take effect immediately and upon approval. This ordinance shall likewise in effect every time that the municipality is placed under Enhanced Community Ouarantine (ECO) by the National Government.

2. Ordinance No. 33, series of 2020

Section 22 - Effectivity Clause will be amended as:

This ordinance shall take effect immediately and upon approval. This ordinance shall likewise in effect every time that the municipality is placed under General Community Quarantine (GCQ) by the National Government.

SECTION 4 - SEPARABILITY CLAUSE – If any provision of this ordinance is held invalid or unconstitutional the same shall not affect the validity and effectivity of the other provisions hereof.

SECTION 5 - EFFECTIVITY CLAUSE - This ordinance shall take effect immediately and upon approval.
