ORDINANCE NO. 50 series of 2020

AN ORDINANCE DECLARING 1ST WEEK OF OCTOBER OF EVERY YEAR AS SENIOR CITIZENS WEEK CELEBRATION IN THE MUNICIPALITY OF TAYTAY, RIZAL AND APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES

WHEREAS, Article II Section 16 of the 1987 Constitution provides that "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature";

WHEREAS, Section 33 of the Magna Carta of Women states that "The State shall ensure special protective mechanisms and support services against violence, sexual abuse, exploitation and discrimination of older person".

WHEREAS, the objective of this ordinance is for the Senior Citizens to have their own days of celebrations, and it is only right for them to have their own special day to be recognized on their significant contribution;

WHEREAS, under Proclamation No. 470, s. 1994 the First Week of October of Every Year is declared as Linggo ng Katandaang Filipino (Elderly Filipino Week);

NOW THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Taytay, Rizal, in regular session assembled, as follows:

Section 1. Short Title of the Ordinance. This Ordinance shall be known as “THE SENIOR CITIZEN’S WEEK ORDINANCE IN THE MUNICIPALITY OF TAYTAY, RIZAL”.

Section 2. Statement of Policy. It is declared policy of the Municipality of Taytay, to give due recognition to the inherent equality between men and women, young and old who played significant and equally crucial role in community and nation building; that their rights should be respected and protected at all times and their welfare be promoted; and that opportunities should be provided to ensure their active participation in the development process of Taytay Rizal.

Section 3. Definition and Terms.

3.1 OSCA – Office of the Senior Citizens Affair. An Office in-charge of senior citizens affair.

3.2 Senior Citizens – a person 60 years old of age and above duly registered as resident of Taytay, Rizal.

3.3 FESCAMT - Federation of Senior Citizen Active Members of Taytay Inc. A non-government federation of the senior citizens operating and with close coordination with the Municipality of Taytay.

3.4 GAD FOCAL POINT SYSTEM - is an interacting and interdependent group of people in all government instrumentalities tasked to catalyze and accelerate gender mainstreaming.

Section 4. Committees. This committee shall be the one who conduct the search of qualified senior citizens that will be awarded as the “Most Outstanding Senior Citizens in the Municipality” and other related activities thereto. It shall be composed of the following:

Section 5. Senior Citizen’s Week Component – Under the supervision of the Local Government Unit concerned, the Senior Citizen’s Week shall have the following:

- A. Recognition for Exemplary Senior Citizen - The Municipal Government of Taytay through the committee shall conduct an annual search for outstanding Senior Citizen which have shown commendable contribution, as the “Most Outstanding Senior Citizen in the Municipality of Taytay”.
- B. Day Activities – there shall be a variety of activities not only limited to the most outstanding senior citizens award but also to include forums, presentation and any activity that will make them feel important and productive.

Section 6. Funding – For the effective implementation of this Ordinance, the Municipal Government of Taytay, Rizal shall appropriate a part from the 1% IRA and or shall appropriate the amount necessary as maybe provided under RA 7160.

Section 7. Separability Clause – If for any reasons, any section of this ordinance shall be held unconstitutional or invalid, other sections, which are not affected thereby, shall continue to be in full force and effect.

Section 8. Repealing Clause – All ordinances, rules and regulations or part thereof, in conflict with, or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.


Section 9. Declaration of Intent to Conform with Law – This Ordinance is subject to national laws, rules and regulation governing its subject matter.

Section 10. Applicability Clause – All other matter relating to the imposition of this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.

Section 11. Effectivity Clause – This Ordinance shall take effect immediately upon the enactment by the members of the Sangguniang Bayan of Taytay, Rizal and approval by the Local Chief Executive.
