ORDINANCE NO. 52 series of 2020

AN ORDINANCE AMENDING PAR. 2, SECTION 5 OF ORDINANCE NO. 41 SERIES OF 2020, KNOWN AS THE OPERATIONAL GUIDELINES ON LOCALIZED CONTAINMENT STRATEGY IN THE MUNICIPALITY OF TAYTAY

WHEREAS, Ordinance No. 41 series of 2020 was enacted by the Sangguniang Bayan last July 9, 2020, which among other things, provides cash assistance to COVID-19 patient as part of the localized containment strategy of the municipality;

WHEREAS, the grant of cash assistance even to a patient who has undergone home quarantine was perceived to have been the main factor in accelerating the transmission of the virulent disease;

WHEREAS, remedial measures be crafted to eliminate any possible causes of transmission by discouraging home quarantine as an option to patient confirmed to have been infected with the virus;

WHEREAS, the fluctuating trend in the rate of transmission of the virus in the municipality is quite revealing that aptly behooves this Sangguniang Bayan to re-calibrate its policy towards

the grants of cash assistance, all for the purpose of ensuring the attainment of its benevolent objectives;

NOW THEREFORE, be it enacted, as it is hereby enacted, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

Section 1. Par. 2, Section 5 of Ordinance No. 41 series of 2020 is hereby amended and shall be read as follows:

2. Cash assistance if there is any, provided however that such assistance shall be granted only to Covid-19 patient who has been admitted to any hospital or quarantine facility or those who are opted to undergo Home Quarantine following strictly the Home Care Checklist provided in the Annex F of Joint Administrative Order No. 2020-0001 of the Department of Health and Department of the Interior and Local Government.

Section 2. Grounds for Disqualification - the following are the grounds for disqualification in receiving Cash Assistance for COVID-19 patient who are opted to undergo Home Quarantine.


1. Going out of the home confinement at anytime during the Quarantine Period.
2. Receiving Guest/s at the home quarantine confinement facility at anytime during the quarantine period.
3. Any violation of IATF Guidelines/Health Protocols, Ordinances.

Provided, that those patients who opted to undergo Home Quarantine shall be exempted from going out of the home confinement in extreme emergency cases or regular medical needs in coordination with the MESU (Dialysis, etc.).

Section 3. Effectivity Clause – This Ordinance shall take effect after fifteen (15) days upon approval hereof.
