ORDINANCE NO. 54 series of 2020

AN ORDINANCE GRANTING THE RECLASSIFICATION OF A PROPERTY APPLIED BY 7 ROSE PETALS DEVELOPMENT CORP. FROM RAWLAND TO COMMERCIAL, LOCATED AT KAYTIKLING, BRGY. DOLORES, TAYTAY, RIZAL

WHEREAS, the property owned by 7 Rose Petals Development Corp., situated at Kaytikling, Brgy. Dolores, Taytay, Rizal, need to be reclassified from Rawland to Commercial purposes;

WHEREAS, the properties subject for reclassification has a total area of 16,359 sq. mtrs., covered by Transfer Certificate Title and Tax Declaration;

WHEREAS, this grant of zoning reclassifications was based on the pertinent documents submitted by the applicant and were verified by the Municipal Assessor and Municipal Planning and Development Officer;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Bayan of Taytay, by the power vested in it by law, in session duly assembled, that:

Section 1. This Ordinance is enacted pursuant to the power vested upon to Sangguniang Bayan of Taytay, Rizal.

Section 2. This Ordinance is enacted relative to a property of 7 Rose Petals Development Corp., situated at Kaytikling, Brgy. Dolores, Taytay, Rizal, that need to be reclassified from Rawland to Commercial purposes.

Section 3. This Ordinance is enacted for the purpose of the following:

- a. To guide, control and regulate the future improvement of the property of 7 Rose Petals Development Corp. To promote and protect the health, safety, peace, comfort, convenience and general welfare of the residents in the nearby area of the location.
- b. To regulate the use of machineries and infrastructure that may cause noise and air pollution in the area.
- c. Provide an effective requirement to secure necessary license and permit to operate.

Section 4. This Ordinance is applicable only to TCT NO. 068-2020001916 with Tax Declaration No. 18-TY-002-14962 containing an area of 16,359 sq. mtrs.

Section 5. That the Sangguniang Bayan of Taytay granted this reclassification based on the pertinent documents submitted by the application and not be subject for any liability if the applicant failed to comply to the requirements of other government agencies concerned or any misrepresentations.

Section 6. Conditions, provisions and guidelines for the improvement and development of the said properties shall be pursuant to existing local rules and regulations, and to the Building Code of the Republic of the Philippines.

Section 7. This Ordinance shall take effect immediately upon its approval.
