ORDINANCE NO. 683 series of 2020

APPROVING SUPPLEMENTAL BUDGET NO. 5 AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY-NINE MILLION TWO HUNDRED FORTY-THREE THOUSAND TWO HUNDRED FORTY-TWO PESOS AND 91/100 (PHP 29,243,242.91) FROM THE SAVINGS AND REVERSION OF VARIOUS EXPENDITURE ITEMS AND ACCOUNTS PAYABLE TO VARIOUS EXPENDITURES IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Department of Budget and Management issued Budget Circular No. 2020-4 dated July 17, 2020, Upgrading the Entry Level of Nurse Positions wherein the salary grade level of Nurse 1 is upgraded from SG11 to SG15 and the position attributes of Nurse II to Nurse VII have been modified accordingly;

WHEREAS, DILG and DBM issued Joint Memorandum Circular No. 2019-01, Guidelines on the Grant of the Performance Based Bonus (PBB) for Officials and Employees of Local Government Units for Fiscal Year 2019; that based on the said JMC it was ascertained that the







Municipality of Taytay has complied with the requirements and is therefore eligible to grant the said PBB to the qualified beneficiaries;

WHEREAS, Municipal Development Council Executive Committee Resolution No. 2020-010 has been issued for the reversion of several projects from the 20% Development Fund to provide for the allocation of several approved projects and some Covid19 related PPAs;

WHEREAS, there is a need for a supplemental budget to address the various financial concerns in the Municipality needed to better serve our constituents;

NOW THEREFORE, the 11th Sangguniang Bayan of Taytay, Rizal, in session hereby decrees:

Section 1. Adaption of Department of Budget and Management Budget Circular No. 2020-4 dated July 17, 2020, Upgrading of the Entry Level of Nurse Positions at the Hon. June V. Zapanta Memorial Emergency Hospital effective retroactively.

The corresponding salary schedule shall be adjusted under Section 3 of this Ordinance.

Section 2. Grant of the Performance Based Bonus for FY2019 as guided by DILG-DBM Joint Memorandum Circular No. 2019-01 to qualified Officials and Employees of the Municipality of Taytay.
