## ABOLISHING THE POSITION ADMINISTRATIVE OFFICER IV IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT, THIS MUNICIPALITY

Section 1. It has been found by the Sangguniang Bayan that the position of Administrative Officer IV in the Accounting Office of this municipality is no longer needed in the said Office.

Section 2. The position Administrative Officer IV in the Accounting Office is hereby abolished and all funding and appropriation of the said position will be reverted to the General Fund.

The intended appropriation of the said position for the FY 2021 Budget shall be reserved as a lumpsum appropriation in the Accounting Office for the proposed creation of other needed plantilla positions.
