### ORDINANCE NO. 686 series of 2020

AN ORDINANCE TEMPORARILY SUSPENDING THE CURFEW HOURS STATED IN ORDINANCE NO. 675 SERIES OF 2020 (MGCQ GUIDELINES), ADJUSTING THE CURFEW HOURS FROM 11:00 PM TO 3:00 AM FOR THE PERIOD OF DECEMBER 15, 2020 TO JANUARY 1, 2021 IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, President Rodrigo Roa Duterte announced on November 30, 2020 that the Province of Rizal still remains under Modified General Community Quarantine (MGCQ) from December 1 to 31, 2020;

WHEREAS, the 11<sup>th</sup> Sangguniang Bayan passed Ordinance No. 675 series of 2020: An Ordinance Prescribing the Updated Guidelines and Regulation of Mobility in the Municipality of Taytay, Province of Rizal declared as one of the areas under Modified General Community Ouarantine, last October 20, 2020;

WHEREAS, despite the COVID-19 pandemic, Filipinos still find ways to celebrate the incoming Holiday Season, adhering to safety and health protocols;

WHEREAS, in order for the constituents of the Municipality of Taytay be able to participate in the activities being held by the Catholic Church as well as other religious sectors this Holiday Season, there is a need to temporarily suspend the current curfew until the period of the Holiday Season is over;

NOW THEREFORE, BE IT ENACTED, as it is hereby enacted by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session assembled, that:

- Section 1. Curfew Hours The adjusted curfew hours shall be from 11:00 PM to 3:00 AM.
- Section 2. Effectivity Period of the Adjusted Curfew The adjusted curfew shall be effective from December 15, 2020 up to January 1, 2021 only.
- **Section 3. Mall Hours** In accordance with the curfew, the Operation of Malls shall be allowed up to 10:00 PM.
- **Section 4.** Limitations This temporary suspension shall be for the sole purpose of accommodating religious activities during the Holiday Season. All IATF, National Laws and Local Ordinances shall remain in full effect.
- **Section 5.** Repealing Clause Any Ordinance, Executive Order, Local Issuances, or Rules and Regulations, or part thereof, which are inconsistent with this Ordinance are hereby repealed and/or modified accordingly.
- **Section 6. Separability Clause -** If for any reasons, any section of this ordinance shall be held unconstitutional or invalid, other sections, which are not affected thereby, shall continue to be in full force and effect.
- Section 7. Applicability Clause All other matters relating to the impositions of this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.
- **Section 8**. **Effectivity Clause -** This Ordinance shall take effect immediately upon approval.
