ORDINANCE NO. 690 series of 2020

ORDINANCE REGULATING THE USE OF BICYCLE AS AN ENVIRONMENTAL SOUND MODE OF TRANSPORTATION IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Section 16 of the Local Government Code of 1991 states that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 447 (a)(5)(v and vi), gives power to the Sangguniang Bayan to approve ordinances to regulate the use of and traffic of streets;





WHEREAS, the Municipality of Taytay, Rizal is promoting cycling as an alternative mode of transportation and a means to maintain the health of every citizen of Taytay, Rizal and protect the environment all at the same time;

WHEREAS, cycling may decongest passengers in public utility vehicles, ensures social or physical distancing among cyclist and may thereby prevent the spread of infectious diseases within the jurisdiction of Taytay, Rizal.

NOW THEREFORE, be it ordained by the Municipal Council of Taytay, Rizal in session assembled, that:

- **Section 1. SHORT TITLE** This ordinance shall be known as "Taytay Bicycle Ordinance of 2020".
- Section 2. DECLARATION OF POLICIES It is the thrust of this Municipality to ensure the safety of all Bikers and to promote health and wellness by encouraging the use of Bicycles by the commuting public.
- **Section 3. BIKING RULES** It shall be mandatory to all Bikers to adhere to the following:
 - 1. All Bikers are mandated to wear helmet and encourage to wear protective gears.
 - 2. All Bikers should ensure that their bicycle is in good running condition and basic protection equipment (light or reflector) shall be installed.
 - 3. Bikers must protect themselves at all times.
 - 4. All road rules should be observed.
 - 5. Road sharing must be observed.
- **Section 4. PARKING FOR BICYCLE** All establishments equipped with parking spaces are mandated to provide parking areas for bicycles.
- **Section 5. BICYCLE DAY** It is hereby declared that every Last Sunday of April of every year as the Bicycle Day in Taytay, Rizal.
- Section 6. TECHNICAL COMMITTEE a technical committee shall be formed by the Municipal Mayor composing of representatives from the Office of the Mayor, Engineering Office, Municipal Planning and Development Office and Traffic Control Management.

The Committee shall determine the location / areas of the proposed bicycle lanes and submit said proposal to the Sangguniang Bayan for approval.

Section 7. BICYCLE LANE – The pilot area for the Bicycle Lane is from 7/11 Kay Tikling up to Jollibee-Uptown.

Parking on designated Bicycle Lane shall be restricted.

- **Section 8. PENALTIES** All violators of this ordinance shall be fined as follows:
 - a. First Offense-Warning
 - b. Second Offense Confiscation of Bike and Seminar
 - c. Third Offense or Habitual -Two Hundred Fifty Pesos (P250.00)

Section 9. IMPLEMENTING OFFICE - The Municipal Public Safety Office (MPSO), Traffic Control Management (TRAFCOM) and the Barangay shall be the implementing agencies of this ordinance.



Section 10. REPEALING CLAUSE - All existing ordinances inconsistent with this ordinance, in part or in full, are hereby repealed accordingly.

Section 11. SEPARABILITY CLAUSE - If for any reason, or reasons, any parts or provisions of this ordinance be held unconstitutional or invalid, parts or provisions which are not affected thereof shall continue to be in full force and effect.

Section 12. EFFECTIVITY - This ordinance shall take effect (15) days upon approval and after posting in conspicuous areas within the Municipality of Taytay.
