ORDINANCE NO. 691 series of 2020

**APPROVING SUPPLEMENTAL BUDGET NO. 6 AN ORDINANCE APPROPRIATING
THE AMOUNT OF FIVE MILLION TWO HUNDRED EIGHTY THOUSAND PESOS (P
5,280,000.00) FROM THE SAVINGS OF VARIOUS PERSONAL SERVICES TO FUND
THE GRANT OF SERVICE RECOGNITION INCENTIVE TO LOCAL GOVERNMENT
EMPLOYEES**

WHEREAS, Administrative Order No. 37 dated December 18, 2020 was issued by the President of the Philippines granting Service Recognition Incentive (SRI) to Government Employees as guided by Budget Circular No. 2020-6 dated December 22, 2020;

WHEREAS, the Local Finance Committee has identified savings from Personal Services and ensure that expenditure is reasonable and will not, in anyway adversely affect the delivery of services to the public;

WHEREAS, the Section 6 of the said Administrative Order tasked the Sangguniang Bayan to determine the grant of one-time SRI to Municipal Government Employees depending on its financial capability subject to PS limitation;

WHEREAS, there is a need for a Supplemental Budget to fund the Service Recognition Incentive (SRI) FY 2020;

NOW THEREFORE, the 11th Sangguniang Bayan of Taytay, Rizal, in session hereby decrees:

Section 1. The grant of a one-time Service Recognition Incentive (SRI) in the amount of TEN THOUSAND PESOS (P 10,000.00) per qualified employee in the Municipal Government of Taytay based on the provisions of Administrative Order No. 37 by the Office of the President of the Republic of the Philippines dated December 18, 2020;


