## ORDINANCE NO. 695 series of 2021

**AN ORDINANCE INSTITUTIONALIZING THE YEARLY GRANT OF FIVE (5)  
KILOS OF RICE TO EVERY FAMILY IN THIS MUNICIPALITY, PROVIDING  
MECHANISM THEREFOR, AND ALLOCATING FUNDS FOR THE PURPOSE**

WHEREAS, social welfare services which include programs that are designed to uplift and promote the welfare of the family and the community is among the functions which every Local Government Unit is mandated to deliver;

WHEREAS, the continuing wave in the distribution of rice and food packs to every family of this municipality proved that social services, in its tangible and material form, become relevant and not merely optional for the government to venture upon;

WHEREAS, the state of our national economy dampened by the current public health crisis, demands enough breathing space for it to gradually heal and recover which concededly would have long term effect in the livelihood and employment of the many;



WHEREAS, conformably with Section 17 of RA 7160, social policy direction may be adjusted through measures that would accord a direct and material benefit or advantage to the inhabitants of this municipality;

NOW THEREFORE, BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

**Section 1. Title:** This ordinance shall be known and may be cited as the “Municipal Yearly Rice Grant Ordinance of 2021”.

**Section 2. Statement of Policy:** It is a declared policy of the Municipal Government to develop, formulate and institute a sound and viable social services program that is responsive in promoting the general welfare, through the adoption of social policy measures calculated to accord a tangible social and economic benefits to its residents.

**Section 3. Municipal Yearly Rice Grant:** There is hereby instituted a Municipal Yearly Rice Grant Program through which every family in this municipality shall be entitled to receive five (5) kilos of rice from the Municipal Government of Taytay, Rizal, once every calendar year, provided that the recipient shall present valid proof of residency in this municipality.

**Section 4. Administrative Provisions:** The Municipal Yearly Rice Grant Program shall be administered by the MSWDO. For this purpose, the Local Chief Executive shall create a council to be known as Inter-departmental Program Coordinating Council (IPCC) to ensure an effective and orderly implementation of the program.

**Section 5. Composition of the Inter-departmental Program Coordinating Council (IPCC):** The IPCC shall be composed of the following: Municipal Mayor, Administrative Officer, MSWD Head, GSO Head, Municipal Budget Officer, Public Information Officer, UPAO Head, and Sangguniang Bayan Member.

**Section 6. Functions of Inter-departmental Program Coordinating Council:** The Inter-Departmental Program Coordinating Council (IPCC) shall perform the following functions:

1. To formulate an Action Plan for the effective implementation of the program.
2. To validate and regularly update the records or master-lists of household dwellers in the municipality.
3. To prepare and recommend the budgetary allocation needed in the program for every calendar year.
4. To organize, designate and determine the number of authorized personnel required during the distribution stage of the program.
5. To formulate and issue the necessary guidelines in the implementation of the program.
6. To coordinate and may request the assistance of Sangguniang Bayan.
7. To perform such other functions as may be necessary for the implementation of this ordinance.

**Section 7. Meetings:** The Inter-departmental Program Coordinating Council (IPCC) shall convene as deemed necessary by the Local Chief Executive to prepare and formulate the Action Plan for the ensuing calendar year and may conduct meeting to deliberate on such other matter on any date as it may determine.

**Section 8. Fund Allocation:** There shall be yearly allocated, the amount necessary to fund the implementation of the yearly program. Such appropriation and all succeeding appropriations needed for the yearly implementation of the program shall be integrated under the item of appropriation for Social Services of the Annual Budget of the Municipality.

**Section 9. Implementing Rules and Regulations:** The Office of the Municipal Mayor shall issue an Implementing Rules and Regulations to ensure that the provisions of this ordinance be properly carried out.


**Section 10. Separability Clause:** If for any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions hereof.

**Section 11. Repealing Clause:** All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provisions of this ordinance are hereby repealed and modified accordingly.


**Section 12. Effectivity Clause:** This ordinance shall take effect fifteen (15) days upon approval and posting in conspicuous places in the municipality.
