ORDINANCE NO. 700 series of 2021

AN ORDINANCE AMENDING PARTS OF SECTION 3 AND SECTION 10 OF ORDINANCE NO. 699 SERIES OF 2021

WHEREAS, the Inter-Agency Task Force (IATF) on the management of emerging infectious diseases had issued Resolution No. 104 series of 2021, on March 20, 2021 placing of the National Capital Region, and the provinces of Bulacan, Cavite, Laguna, and Rizal under General Community Quarantine (GCQ) for the limited period of March 22, 2021 until April 4, 2021;

WHEREAS, in compliance with the said directives the 11th Sangguniang Bayan of Taytay had enacted Ordinance 698, series of 2021 for this purpose;

WHEREAS, the sudden rise of positive cases within the National Capital Region (+) Bubble to mention including Provinces of Rizal, Bulacan, Laguna and Cavite and other highly urbanized cities in the National Capital Region leads to the immediate recommendation of the

IATF on the declaration of **Enhanced Community Quarantine (ECQ)** as stated in Resolution 106-A dated March 27, 2021 and Resolution 106-B dated March 28, 2021 to sustained and resolved the need to lower the number of positive cases;

WHEREAS, the Office of the Executive Secretary to President had issued a Memorandum Circular on the approval of the President of the Republic of the Philippines Rodrigo Duterte on the recommendation of the IATF aiming to slow down the surge in COVID-19 cases and to allow the health system to cope and to protect more lives, effective 12:01 a.m. of March 29 until the end of April 4, 2021;



WHEREAS, the 11th Sangguniang Bayan of Taytay enacted Ordinance No. 699, series of 2021, implementing the IATF Resolutions 106-A and 106-B s. 2021 based on the amended Omnibus Guidelines for Quarantine with additional instructions and restrictions for the Municipality of Taytay, Rizal;

WHEREAS, as per the announcement of the Office of the President, the Enhanced Community Quarantine (ECQ) of NCR+ including the Municipality of Taytay, Rizal has been extended up to April 11, 2021;

WHEREAS, for the continuous delivery of service to the constituents of the municipality particularly to those APOR working during the evening and during times of emergencies, some amendments to the previously enacted Ordinance No. 699 series of 2021 are necessary;

NOW THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:


Section 1. The amended Section 3 and Section 10 of Ordinance No. 699 series of 2021 shall be as follows:

Section 3. Additional Instructions and Restrictions – As stated in the Omnibus Guidelines on The Implementation of Community Quarantine in The Philippines of the IATF, Section [8] General Provisions, item No. 4 “LGUs shall adopt measures lawful and necessary to implement and enforce the minimum public health standards”, the following shall likewise be implemented within the jurisdiction of the Municipality of Taytay.

- A. Curfew Hour** - 6:00 PM to 5:00 AM. Exempted from the curfew are legally on duty employees on their way home or to their workplace.
- B. Face Mask and Face Shield** – mandatory use at all times in all Establishments and Public Places. Except for motor riding and biking where only Face Mask is mandatory but it is recommended to wear eye shield / goggles specially those who are not wearing a full-face helmet.
- C. Total Liquor Ban** – The sale and consumption of all types of alcoholic drinks shall not be allowed.
- D. Public Market / All Recognized Talipapas / Convenience Store / Sari-sari Store** – shall be in operation from 5:00 AM to 6:00 PM only, delivery of product shall not be prohibited.

As per the PNP-Taytay recommendation, it is recommended for establishments to have one (1) entrance and multiple exits to control the flow of foot traffic.

- E. Food Deliveries** – shall be allowed for twenty-four (24) hours. However, Drive Thru is still not allowed beyond 6:00 PM



- F. **Pharmacy / Drug Store** – shall be allowed to operate for twenty-four (24) hours. Groceries part of the drugstores / pharmacy shall remain closed during the curfew hours.
- G. **eBingo / eGames / Computer Shops / Internet Cafe** – operations of these establishments shall be temporarily suspended (closed)
- H. **Personal Services (Salon, Barbershop and Spa) / Gym** - operations of these establishments shall likewise be temporarily suspended.
- I. **Contact Sports (Basketball, Volleyball, etc.) and Non-Contact (Group) Sports** – shall not be allowed for the duration of Enhanced Community Quarantine (ECQ). Individual Sports (Exercise) allowed from 6:00 AM to 9:00 AM.
- J. Any guidelines/memorandum/advisory from the Department of Trade and Industry and other Department / Sector of the National Government pertaining to the duration of the ECQ shall likewise be implemented.
- K. Minimum health protocols shall be observed at all times. All allowed establishments shall strictly follow health protocols and observe physical / social distancing in accordance to Ordinance No. 653 series of 2020 of this municipality at all times.

Section 10. Effectivity Clause - This ordinance shall take effect immediately and upon approval. **This Ordinance shall likewise be in effect every time that the municipality is placed under Enhanced Community Quarantine (ECQ) by the National Government.**

Section 2. Separability Clause - If any provision of this ordinance is held invalid or declared to be unconstitutional, the same shall not affect the validity and effectivity of the other provisions not affected thereby.

Section 3. Repealing Clause - All Ordinances and administrative regulations or part thereof which is inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity Clause - This ordinance shall take effect immediately and upon approval.
