## **ORDINANCE NO. 720 series of 2021**

**AN ORDINANCE GRANTING THE RECLASSIFICATION OF PROPERTIES  
APPLIED BY BON AVENIR REALTY DEVELOPMENT CORPORATION, FOR  
THEIR SUBDIVISION PROJECT "EAST RIVIERA SUBDIVISION", FROM  
RICE LAND TO RESIDENTIAL LAND, LOCATED AT SITIO TABING ILOG,  
BRGY. STA. ANA, TAYTAY, RIZAL**

WHEREAS, the properties acquired by Bon Avenir Realty Development Corporation, situated at Sitio Tabing Ilog, Brgy. Sta. Ana, Taytay, Rizal, needs to be reclassified from Rice Land to Residential Land;

WHEREAS, the properties subject for reclassification has a total area of 12,903 sq.m., covered by Transfer Certificate Titles and Tax Declarations;

WHEREAS, this grant of zoning reclassifications was based on the pertinent documents submitted by the applicant and were verified by the Municipal Assessor and Municipal Planning and Development Officer;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Bayan of Taytay, by the power vested in it by law, in session duly assembled, that:

**Section 1.** This Ordinance is enacted pursuant to the power vested upon to Sangguniang Bayan of Taytay, Rizal.

**Section 2.** This Ordinance is enacted relative to the properties of Bon Avenir Realty Development Corporation, situated at Sitio Taging Ilog, Brgy. Sta. Ana, Taytay, Rizal, that needs to be reclassified from Rice Land to Residential Land.

**Section 3.** This Ordinance is enacted for the purpose of the following:

- a. To guide, control and regulate the future improvement of the properties. To promote and protect the health, safety, peace, comfort, convenience and general welfare of the residents in the nearby area of the location.
- b. To regulate the use of machineries and infrastructure that may cause noise and air pollution in the area.
- c. Provide an effective requirement to secure necessary license and permit to operate.

**Section 4.** This Ordinance is applicable only to the following properties:

**Section 5.** That the Sangguniang Bayan of Taytay granted this reclassification based on the pertinent documents submitted by the application and not be subject for any liability if the applicant failed to comply to the requirements of other government agencies concerned or any misrepresentations.


**Section 6.** Conditions, provisions and guidelines for the improvement and development of the said properties shall be pursuant to existing local rules and regulations, and to the Building Code of the Republic of the Philippines.

**Section 7.** All previously approved resolution / ordinance pertaining to this property shall be superseded by this Ordinance.

**Section 8.** This Ordinance shall take effect immediately upon its approval.
