ORDINANCE NO. 721 series of 2021

AN ORDINANCE GRANTING DISCOUNT SUBSIDY ON MAYOR'S PERMIT FEE AND ARTICULATING OTHER REGULATORY FEES AS BASIS OF SUBSIDY FOR THE GARMENTS PRODUCERS / TIANGGE INDUSTRY AND FOR OTHER PURPOSES

WHEREAS, President Rodrigo Roa Duterte issued Proclamation No. 1218 series of 2021 to further extend the period of the declaration of State of Calamity in the entire Philippines until September 12, 2022;

WHEREAS, the Local Government Unit of Taytay under the administration of Hon. Mayor George Ricardo R. Gacula II and the Sangguniang Bayan of Taytay constantly endeavors to augment the needs of the Garments producers that is among the leading industry in the Municipality;

WHEREAS, the continued restrictions brought about by the COVID-19 pandemic have limited the operations of the garment producers (“tiangge”) and hindered the full potential of the should-be thriving businesses thus the need to assist, in any form of relief, the sector that placed the Municipality of Taytay on the national map as the Garments Capital of the Philippines;

NOW THEREFORE, BE IT ORDAINED by the 11th Sangguniang Bayan of Taytay, in a session duly assembled that:

SECTION 1. Discounts / Subsidy and Adjustments – Parts of Ordinance 612 series of 2017: “Revising the Revenue Code of the Municipality of Taytay, Province of Rizal”, are temporarily amended as follows:

Section 17 II 43. General Merchandise Store		
43.3 Class C 50,001 – 150,000 Capital (less 50% discount from 1,100)

Chapter IV Article D. Sanitary Inspection Fee		
Section 102. 1 Residential Establishments		
RTW per stall (as is)		200.00
RTW lessors, shall be classified under		
Private Market/Tiangge Operations		5,000.00
Chapter V Article D. Service Charges for Garbage Collection		
Section 128. Imposition of Fee – Commercial / Service Establishments		
RTW per stall (less 50% discount from 300)		150.00
RTW lessors, shall be classified under		
Private Market/Tiangge Operations		2,500.00


SECTION 2. Repealing Clause - All existing Ordinances of this Municipality which are inconsistent with the provisions of this Ordinance are hereby repealed, revised, amended or modified accordingly.

SECTION 3. Effectivity Clause – This Ordinance shall take effect immediate upon approval and after posting in conspicuous areas within the Municipality.

This Ordinance shall be in effect until September 12, 2022.
