ORDINANCE NO. 722 series of 2021

APPROVING SUPPLEMENTAL BUDGET NO. 4 AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION ONE HUNDRED SEVENTEEN THOUSAND SIX HUNDRED TWENTY-SIX PESOS AND 07/100 (PHP 2,117,626.07) FROM THE SAVINGS ON VARIOUS EXPENDITURE ITEMS TO FUND VARIOUS EXPENDITURE ITEMS NEEDED BY THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Republic Act No. 11466, otherwise known as the "Salary Standardization Law of 2019", mandates the modification of the Salary Schedule for Civilian Personnel;

WHEREAS, the Department of Budget and Management issued Local Budget Circular No. 132 dated January 6, 2021 prescribing the guidelines, rules and regulations for the implementation

of the second tranche of the modified Salary Schedule for Civilian Personnel stipulated under RA No. 11466;

WHEREAS, there is an immediate concern in the funding for the Terminal Pay of some employees who retired from work during the year;

WHEREAS, there is an immediate need for additional appropriation for much needed operating expenditures;

WHEREAS, there is a need for a Supplemental Budget to better address the financial concerns in the Municipality;

NOW THEREFORE, the Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby decrees:

SECTION 1. Adaption of the Department of Budget and Management Local Budget Circular No. 132 dated January 6, 2021, Implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to Republic Act (RA) No. 11466.

The corresponding salary schedule shall be adjusted under Section 4 of this Ordinance.

SECTION 2. Authorizing the grant of Terminal Pay to retired employees.

SECTION 3. Authorizing the reversion of Capital Expenditures to appropriation for Operating Expenditures.
