ORDINANCE NO. 725 series of 2021

AN ORDINANCE EXEMPTING ALL TRICYCLE OWNERS AND OPERATORS OF TRICYCLE-FOR-HIRE FROM THE ANNUAL PAYMENT OF THE PERMIT TO OPERATE OR TRICYCLE FRANCHISE FOR THE YEAR 2022 AND PRESCRIBING RULES THEREOF

WHEREAS, all public utility tricycles operating within the territorial jurisdiction of Taytay, Rizal as a condition for the privilege shall annually secure and pay the necessary Mayor's Permit to Operate prior to tricycle operation;

WHEREAS, COVID-19 pandemic has greatly affected the lives of the general public and constituents of Taytay, Rizal for several months already specifically their health and safety. Moreover, their livelihood has suffered economic reverses causing extreme and irreversible impact in the financial aspect of their families most specifically our tricycle owners, operators and drivers that were prohibited to operate for a specific period of time;

WHEREAS, while the country is still battling the COVID-19 pandemic and while waiting for the arrival of vaccines thereto, a new strain of COVID-19 virus globally known as SARS-CoV-2 has unfortunately entered our country demanding concerted and immediate efforts from both the National and Local Government units in order to relentlessly address and prevent its untoward spread in the country;

WHEREAS, the Municipality of Taytay, Rizal, has accredited tracing applications and tricycle ride-hailing application services for the constituents of Taytay, Rizal in order to promote the use of information and communications technology for the effective, efficient, secure and convenient use of tricycle services within its territorial jurisdiction and has likewise accredited and spearheaded the use of tracing app for the improvement of the contact tracing operations in the municipality;

WHEREAS, Municipal Ordinance No. 44 series of 1999, and its' subsequent amendments, prescribed the rules and regulations relative to the issuance of tricycle franchise within the Municipality of Taytay;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, duly assembled, to Enact an Ordinance that EXEMPTING ALL TRICYCLE OWNERS AND OPERATORS OF TRICYCLE-FOR-HIRE FROM THE ANNUAL PAYMENT OF THE PERMIT TO OPERATE OR TRICYCLE FRANCHISE FOR THE YEAR 2022 AND PRESCRIBING RULES THEREOF.

SECTION 1. That all tricycle Franchise applicant shall show proof that the tracing application and tricycle ride-hailing application services from accredited application providers of the Municipality of Taytay, Rizal has been duly downloaded as a condition in the processing, approval and release of the permit to operate.

SECTION 2. That this Ordinance shall be valid for this year 2022 ONLY.

SECTION 3. That those who had already renewed their franchise for the year 2022, shall be credited to the following year 2023.

SECTION 4. Repealing Clause – All existing ordinance inconsistent with this Ordinance, in part or in full, are hereby repealed accordingly.

SECTION 5. Separability Clause – If for any reasons, any parts or provisions of this Ordinance be held unconstitutional or invalid, parts or provisions which are not affected thereof shall continue to be in full force and effect.
