ORDINANCE NO. 726 series of 2021

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 685 SERIES OF 2020: AN ORDINANCE CREATING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC), PRESCRIBING ITS COMPOSITION AND FUNCTIONS, AND FOR OTHER PURPOSES

WHEREAS, Section 14, Article II of the 1987 Constitution articulates that "The State recognizes the role of the women in nation-building, and shall ensure the fundamental equality before the law of women and men";

WHEREAS, Republic Act No. 9208, otherwise known as the "Anti-Trafficking in Persons Act of 2003", declares that the State values the dignity of every human person and guarantees the respect of individual rights. In pursuit of this policy, the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect the people from any threat of violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons, not only to support trafficked persons



but more importantly, to ensure their recovery, rehabilitation and reintegration into the mainstream of the society;

WHEREAS, Republic Act No. 9262, otherwise known as "The Anti-Violence Against Women and their Children Act of 2004", emphasizes the commitment of the State on safeguarding the dignity of women and children while ensuring full respect of their human rights and to protect them from violence and threats to their personal safety and security;

WHEREAS, Republic Act No. 9710, also known as "The Magna Carta of Women", affirms the role of women as it seeks to eliminate discrimination against women by recognizing protecting, fulfilling and promoting the rights of Filipino women, especially those in the marginalized sector;

WHEREAS, the Department of Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), and Department of Justice (DOJ) have issued Joint Memorandum Circular No. 2010-01, dated October 18, 2010, directing the Municipal Mayors and other entities concerned to create a Local Council on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC);

WHEREAS, the 11th Sangguniang Bayan of Taytay, Rizal passed Ordinance No. 685 series of 2020: An Ordinance Creating the Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC), Prescribing its Composition and Functions, and for Other Purposes;

WHEREAS, in a meeting conducted by LCAT-VAWC, some representatives are found to be necessary to the local committee and needed to be included in the composition of said local committee;

NOW THEREFORE, BE IT ENACTED, as it is hereby enacted by the 11th Sangguniang Bayan of Taytay, Rizal, in session assembled, by virtue of the power vested in it by law, that:

Additional members / office shall be added to the Composition of the Local Committee on Anti-Trafficking and Violence against Women and their Children thus, Section 3 of Ordinance 685 series of 2020 shall be amended and be read as follows:

- **Section 2.** Repealing Clause Any Ordinance, Executive Order, Local Issuances, or Rules and Regulations, or part thereof, which are inconsistent with this Ordinance are hereby repealed and/or modified accordingly.
- **Section 3. Separability Clause -** If for any reasons, any section of this ordinance shall be held unconstitutional or invalid, other sections, which are not affected thereby, shall continue to be in full force and effect.
 - **Section 4**. **Effectivity Clause -** This Ordinance shall take effect after its approval.
