ORDINANCE NO. 729 series of 2021

AN ORDINANCE GRANTING PANDEMIC INCENTIVES ON REGULATORY FEES FOR BUSINESSES APPLYING FOR RENEWAL OF BUSINESS PERMITS IN THE MUNICIPALITY OF TAYTAY, RIZAL AND FOR OTHER PURPOSES

WHEREAS, Section 192 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "local government units, through ordinances duly approved, grant tax exemptions, incentives or relief under such terms and conditions as they may deem necessary;

WHEREAS, Section 447(2)(ii) also of the Local Government Code authorizes the Sangguniang Bayan upon a majority vote of all its members, to enact ordinances levying taxes, fees or charges, prescribing the rates thereof and to grant exemptions, incentives or relief;

WHEREAS, the COVID-19 pandemic has resulted to unprecedented rate of unemployment, business slow down and economic shrinking, thereby causing loss of income and opportunities as well as financial difficulties across the globe;

WHEREAS, the Municipal Government of Taytay, well aware and sympathetic of the difficulties of its constituents, understands that there is a widespread economic mishap that further burdens business owners to stay afloat and operational;

WHEREAS, to mitigate the economic cost and losses stemming from the COVID-19 pandemic and to boost the local economy by inculcating a business-friendly environment, an incentive for dutiful business tax payers is necessary;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled that:

SECTION 1. Title - This Ordinance shall be known as "An Ordinance Granting Pandemic Incentives for Dutiful Business Taxpayers in the Municipality of Taytay".

SECTION 2. Declaration of Incentive - Dutiful Business Tax Payers in the Municipality of Taytay applying for renewal of their business permits are hereby granted tax incentives for the year 2022, provided that they have settled all their tax obligations before or until the last day of payment of business tax for the year 2021. The incentives are as follows:

- a. **50% DISCOUNT** on Mayor's Permit Fee for all businesses with Gross Sales / Receipts of less than One (1) Million
- b. **20% DISCOUNT** on Mayor's Permit Fee for all businesses with Gross Sales / Receipts of One (1) Million and above
- c. **50% DISCOUNT** on Mayor's Permit Fee, Garbage Fee, Sanitation Fee and Occupational Permit Fee for Sari-sari Store, Barbershop, Parlor / Salon and Internet Cafe
- d. **50% DISCOUNT** on Garbage Fee, Sanitation Fee and Occupational Permit Fee for Non-stock, Non-Profit Educational Entities that have opted not to transition to Online Classes for 2021.

SECTION 3. Coverage - All compliant and duly registered business entities within the jurisdiction of this Municipality are eligible to avail of this pandemic incentive program. All delinquent registered business accounts in the Municipality for the year 2021 shall be NOT be qualified to avail of this pandemic tax incentive program. All business establishments covered by Ordinance No. 721, series of 2021 shall NOT be qualified under this Ordinance, so as to avoid double concession.

SECTION 4. Assessment of Eligibility - the Business Permit and Licensing Office shall assess whether the business taxpayer is eligible or not for the said pandemic incentive and under which category the business entity shall fall under.

SECTION 5. Duration - A dutiful business owner may avail of this pandemic relief only until the last day of payment of business tax for the year 2022. Thereafter, there shall be no grant of pandemic incentive to any business owners.

SECTION 6. Information Dissemination - Aside from the publication of this ordinance in a newspaper of general circulation, all barangays within the Municipality of Taytay shall contribute in disseminating public information through posters, tarpaulins or streamers to be placed in conspicuous places within their respective areas of jurisdiction.


SECTION 7. Separability Clause - If for any reason or reasons any part or provisions of this Ordinance shall be held to be unconstitutional or invalid by the proper authorities, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 8. Repealing Clause - All previous Ordinances or statutes inconsistent with this Ordinance shall be deemed repealed or modified accordingly.

SECTION 9. Effectivity Clause - This Ordinance shall take effect fifteen (15) days upon completion of its posting in conspicuous places within the Municipality.
