APPROVING SUPPLEMENTAL BUDGET NO. 1 AN ORDINANCE
APPROPRIATING THE AGGREGATE AMOUNT OF THIRTY-TWO MILLION
FIVE HUNDRED SIXTY-ONE THOUSAND EIGHT HUNDRED THIRTY-TWO
PESOS AND 12/100 (PHP 32,561,832.12) FROM THE UNAPPROPRIATED
BALANCE RETAINED EARNINGS FY 2021, FROM UNAPPROPRIATED
BALANCE FROM REVERSION OF ACCOUNTS PAYABLE PER ORDINANCE
NO. 733 SERIES OF 2022, AND FROM VARIOUS EXPENDITURE ITEMS AND
OTHER SOURCES TO FUND VARIOUS PRIORITY PROGRAMS, PROJECTS
AND ACTIVITIES IN THE MUNICIPALITY

WHEREAS, the Accounting Office has determined the Unappropriated Balance Retained Earnings FY 2021 which is available for Supplemental Appropriation as ₱ 2,695,322.26 for 20% Development Fund;

WHEREAS, various Accounts Payable items in the Financial Statement of the Municipality in the amount of ₱ 3,866,509.86 which are more than 2 years and determined to be

non-existent reverted to the General Fund as Unappropriated Balance from Reversion of Accounts Payable per Ordinance No. 733 series of 2022;

WHEREAS, the Local Financial Committee has identified other expenditure items and some Continuing Appropriations for reversion with assurance that expenditures are reasonable and will not, in any way adversely affect the delivery of service to the public;

WHEREAS, there are programs, projects and activities that needed funding for their immediate implementation;

WHEREAS, a supplemental budget is needed to address the various needs of the constituents in the Municipality;

NOW THEREFORE, the Sangguniang Bayan in session hereby decrees the approval of Supplemental Budget No. 1:
