## ORDINANCE NO. 740 series of 2022

### AN ORDINANCE INSTITUTIONALIZING THE CASH GIFT AMOUNTING TO PHP 4,000.00 FOR ALL REGISTERED AND QUALIFIED SENIOR CITIZENS IN THE MUNICIPALITY OF TAYTAY

WHEREAS, it is the policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life;

WHEREAS, in support of the State of Policy, Republic Act. A. 9994, also known as the Expanded Senior Citizens Act of 2010 was passed with the objective to give full support to the improvement of the total well-being of the elderly and their full participation in society;

WHEREAS, the Sangguniang Bayan of Taytay passed Resolution No. 99 series of 2016 authorizing the Local Chief Executive Hon. George Ricardo R. Gacula II to establish a Municipal Senior Citizens Social Fund (Cash Gift) for qualified Senior Citizens of Taytay, Rizal;



WHEREAS, with the current increase in the over-all budget of the Municipality and with the ongoing pandemic situation, it is high time that the municipality increase the Local Social Pension (Cash Gift) of the Senior Citizens in the Municipality;

NOW THEREFORE, BE IT ORDAINED by the 11<sup>th</sup> Sangguniang Bayan of Taytay, in a session duly assembled that:

**Section 1. Short Title** – This ordinance shall be known as “**Taytay Senior Citizen Cash Gift Ordinance of 2022**”

**Section 2. Purpose** - The purpose of this Ordinance is to ensure the elderly citizens in the municipality to be happy and enjoy a decent quality of life such as emotional well-being, close interpersonal relationships with family members and friends even in their twilight years.

**Section 3. Coverage** – This ordinance shall cover all Registered and Qualified Senior Citizens of the Municipality of Taytay that is not included in the Social Pension Program of the National Government.

**Section 4. Requirements** - senior citizens shall submit to the Executive Department a copy of:

- Senior Citizens I. D. issued from the Office of Senior Citizens Affairs,
- Comelec Certification/Registration I.D. and
- Barangay Clearance.

Beneficiaries from National Social Pension of DSWD is exempted to avail the Municipal Senior Citizens Social Fund (Cash Gift).

The above requirements shall be strictly implemented.

**Section 5. Validation and Monitoring** – The Office of the Senior Citizens Affairs (OSCA) shall facilitate the validation and monitoring of the registered Senior Citizens in the Municipality.

**Section 6. Budget Appropriation** – for the implementation of this Ordinance, the requisite funds shall be sourced from the Senior Citizens Social Fund and other local income which shall be included in the Annual Budget Appropriation.

**Section 7. Releasing of Cash Gift** – All qualified Senior Citizens of the Municipality shall receive a lumpsum amount of PHP 4,000.00 annually.

The Office of the Senior Citizens Affairs (OSCA) together with the Municipal Social Welfare and Development (MSWD) shall manage the releasing of such fund.


**Section 8. Separability Clause** - Any section or portion of this Ordinance that shall be declared by any Court as unconstitutional or invalid, such decision shall not affect the validity of other Sections or provisions of this Ordinance and shall remain in full force and effect.

**Section 9. Repealing Clause** - All other ordinances, rules and regulations that are in conflict or contrary to the provisions of this Ordinance hereby repealed or modified accordingly.

**Section 10. Effectivity Clause** - This ordinance shall take effect immediately upon its approval.
