## ORDINANCE NO. 781 series of 2023

AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 1 AMOUNTING TO FORTY- FIVE MILLION EIGHT HUNDRED THIRTY THOUSAND FOUR HUNDRED SIXTY PESOS (PHP 45,830,460.00) FROM THE UNAPPROPRIATED SURPLUS TO COVER EXPENDITURES RELATED TO THE PRIORITY PROGRAMS OF THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL

WHEREAS, Ordinance No. 762, series of 2022 was enacted approving the Annual Budget for Fiscal Year 2023 of the Municipal Government of Taytay, Rizal involving the amount of One Billion Six Hundred Thirty-Eight Million Seven Hundred Fifty-Seven Thousand Three Hundred Fifty-Five Pesos (Php 1,638,757,355.00);

WHEREAS, there is a need to appropriate a Supplemental Budget in the amount of Forty-Five Million Eight Hundred Thirty Thousand Four Hundred Sixty Pesos (Php 45,830,460.00) to fund and implement the priority projects of the Municipal Government of Taytay;

WHEREAS, the Municipal Accountant attested that the surplus amounting to Forty-Five Million Eight Hundred Thirty Thousand Four Hundred Sixty Pesos (Php 45,830,460.00) is unappropriated and available for Supplemental Appropriation to support the financial grant to senior citizens and priority programs of Taytay, Rizal;

WHEREAS, it is imperative for the Sangguniang Bayan of Taytay, Rizal to approve the Supplemental Budget No. 1, General Fund for Calendar Year 2023 in order to cover the expenses for the implementation of Ordinances No. 740 series of 2022 of the Municipal Government;

NOW THEREFORE, BE IT ORDAINED, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

**Section 1.** Appropriation - The amount of Forty-Five Million Eight Hundred Thirty Thousand Four Hundred Sixty Pesos (Php 45,830,460.00) is hereby appropriated as integral part of the General Fund Budget for the year 2023 by way of Supplemental Budget No. 1.
