**AN ORDINANCE AMENDING ORDINANCE NO. 768 SERIES OF 2023 ALSO
KNOWN AS THE “GAWAD KABATAANG-TAYTAY DANGAL NG MAGULANG
ORDINANCE OF 2022”**

WHEREAS, it is the declared policy of the Municipal Government of Taytay, Rizal to give encouragement and assist the poorest of the poor but deserving students to attain quality education for their development under the maxim that “those who have less in life shall have more in law”;

WHEREAS, Section 16 or the General Welfare clause of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare...”;

NOW THEREFORE, be it enacted by the Sangguniang Bayan of Taytay, Rizal, in a session duly assembled that:

Section 1. Title - This Ordinance shall be known and referred to as the “**Gawad Kabataang-Taytay Dangal ng Magulang Ordinance of 2022**”.

Section 2. Rationale - The Gawad Kabataang-Taytay Dangal ng Magulang is a unique recognition accorded to Young Taytayefio students, who despite poverty and economic challenges have mustered the will to continue their education by doing odd jobs or informal means to support their studies and help their respective families.

It aims to acknowledge not only the academic performances of students but also the students’ inspiring display of self-reliance, diligence and hard work and recognize the nobility of the “Kabataang-Taytay Dangal ng Magulang”.

In appreciation of the same, it is but fitting that those awardees from all public elementary and junior and senior high schools be given Scholarship Grant under the “Iskolar ng Bayan” Program.

Section 3. The “Gawad Kabataang-Taytay Dangal ng Magulang” Selection Committee, Composition, Duties and Functions - There is hereby created a “Gawad Kabataang - Taytay Dangal ng Magulang” Selection Committee which shall be composed of the following:

- 1. The Parents-Teachers Association Executive Officers in every Taytay public schools;
- 2. Taytay Public School Heads and Teacher-Advisers;
- 3. The Municipal Social Welfare and Development Officer or designated Representative;
- 4. The Chairperson of the Barangay Council for the Protection of Children or designated Representative from each Barangays in Taytay
- 5. A Representative from the Office of the Municipal Mayor.

The “Gawad Kabataang-Taytay Dangal ng Magulang” Selection Committee shall be responsible for the following:

- 1. Scout for student-nominee/s and select him/her for the grant/award using the approved set of criteria stipulated in Section 5 of this Ordinance;
- 2. Conduct home visitation to determine the status in life of the student-nominee/s and the veracity of the nomination;
- 3. Facilitate proper documentation in support of the nomination and final selection; and
- 4. Submit all nomination documents of selected student-nominee/s from each school to the Municipal Management Committee for final review, authentication and concurrence.

Section 4. The “Gawad Kabataang-Taytay Dangal ng Magulang” Municipal Management Committee, Composition, Duties and Functions - There is hereby created a “Gawad Kabataang-Taytay Dangal ng Magulang” Management Committee which shall be composed of the following:

The Municipal Mayor shall have the power to include and appoint other members of the Committee as the need arises.

Section 5. **Criteria** - The awardee shall be selected, nominated, and chosen on the basis of the following criteria:

- 1. The student-nominee should be a graduating elementary student, junior high school completer or graduating senior school student from any of the public elementary, junior high and senior high schools under DepEd Taytay;
- 2. The student-nominee should be a resident of the Municipality of Taytay, Rizal for at least two (2) years prior to the nomination;
- 3. The student-nominee should come from an economically-challenged family (poorest of the poor) with no regular income;
- 4. The student-nominee is doing odd job or informal means to support his/her schooling or his/her family;

5. The student-nominee should possess good moral character; and
6. The student-nominee should have no failing grade/s or no dropped subjects for the current school year prior to the nomination.

Section 6. Awards and Benefits - The awardee/s of the “Gawad Kabataang-Taytay Dangkal ng Magulang” shall be given a plaque of recognition and shall be automatically entitled to a scholarship grant; as follows:

Section 6.1 Awardee/s from the Elementary School Level - a possible maximum amount of **THREE THOUSAND PESOS (Php 3,000.00)** to be awarded during their school’s commencement exercises and be included in the scholarship program of Taytay until he/she finishes junior high school in any public schools in Taytay;

Section 6.2 Awardee/s from the Junior High School Level - a possible maximum amount of **FIVE THOUSAND PESOS (Php 5,000.00)** to be awarded during their school's commencement exercises and be included in the scholarship program of Taytay until he/she finishes senior high school in any public schools in Taytay;

Section 6.3 Awardee/s from the Senior High School Level - a possible maximum amount of **TEN THOUSAND PESOS (Php 10,000.00)** to be awarded during their school’s commencement exercises and be included in the scholarship program of Taytay until he/she finishes his/her college course in any college institutions or universities;

Section 6.4 Up to two (2) Runners-up from the Elementary (2), Junior High School (2), and Senior High School (2) are entitled to a one-time cash incentive with the amount not exceeding Three Thousand Pesos (Php 3,000.00) to be determined by the Management Committee.

Section 7. Discontinuation of Benefits - the scholarship grant for the awardees based on this ordinance may be discontinued by the Management Committee if the following are committed by the recipient:

- a. The awardee from the elementary and high school level transfers to any school outside Taytay;
- b. The awardee incurs a failing grade or is dropped from any subject;
- c. The awardee transfers to another residence outside Taytay, Rizal;
- d. The awardee has been involved in misconduct or law-breaking activities; and
- e. The awardee shifts course other than what he/she had enrolled during his/her 1st year in college.

Section 8. Appropriations - For purpose of this Ordinance, an initial appropriation of FIFTY THOUSAND PESOS (Php 50,000.00) is hereby appropriated under the Office of the Mayor or be augmented as necessary.

Section 9. The Office of the Mayor is hereby designated to implement this Ordinance.

Section 10. Presentation of Award - The award shall be presented to each awardee at the award presentation ceremonies every year during the commencement exercises of each public elementary or junior and senior high school identified by the Department of Education-Taytay Sub-Offices and/or at the school where the awardee will graduate.

Section 11. Separability Clause - If, for any reason, any section, provision or clause on this Ordinance is declared to be unconstitutional, others which are not affected thereby shall be in full force and effect.

Section 12. Repealing Clause - All ordinances, resolutions, rules and regulations and executive or administrative orders which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 13. Effectivity - This Ordinance shall take effect upon its approval and posting.


