**AN ORDINANCE PROVIDING SCHOLARSHIP GRANTS TO THE
DESERVING CHILDREN OF MUNICIPAL TASK FORCE APPOINTEES IN
THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND FOR

WHEREAS, Section 447 (a)(5)(xi) of the Local Government Code of 1991 provides that the Sangguniang Bayan has a duty to “establish a scholarship fund for poor but deserving students residing within the municipality in schools located within its jurisdiction”;

WHEREAS, the Local Government Unit of Taytay enacted Ordinance No. 758 or the Taytay Expanded Educational Assistance Program Ordinance of 2022 to provide broader educational assistance to deserving students that aims to make the program more inclusive;

WHEREAS, to further expand the aforementioned program, the Municipal Government of Taytay intends to include qualified children of force multipliers appointed as members of officially created Municipal LGU Task Forces that augment the delivery of essential community services to the people in their sitios, puroks or barangays;

NOW THEREFORE, BE IT ORDAINED, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, that:

Section 1. Short Title - This Ordinance shall be known as the “**Taytay Community Service Scholarship**”.

Section 2. Scope - This Ordinance shall cover the children of qualified personnel currently serving in the Municipality of Taytay, Rizal, during the selection process of scholarship, as part of any officially created Municipal Task Force and is not under any job order contract or have any employer-employee relationship with the LGU.

Section 3. Eligibility - The beneficiaries under this Ordinance shall:

- be a bonafide resident of Taytay, Rizal;
- be a child of a member of any duly created Task Force by the Local Chief Executive of the Municipality of Taytay;
- have a parent serving in any officially created Municipal Task Force for not less than twelve (12) months during the time of selection of scholars; and
- be enrolled in either secondary level, college level or the Alternative Learning System.

Section 4. Classification of Beneficiaries - The following areas listed below where a Municipal Task Force is designated or deployed shall be used to classify the minimum of thirty-five (35) recipients of the educational assistance under this Ordinance:

- a. Barangay San Isidro = 5 scholars
- b. Barangay Dolores = 5 scholars
- c. Barangay Muzon = 5 scholars
- d. Barangay Sta. Ana = 5 scholars
- e. Barangay San Juan = 5 scholars
- f. Lupang Arenda, Brgy. Sta. Ana = 5 scholars
- g. Floodway Area, Brgy. San Juan = 5 scholars

4.1 The recipient of the educational assistance shall be the child of the top performers of the Task Force from their respective areas as screened by the Office of the Mayor or its duly assigned department.

4.2 The amount to be given to the scholar and the releasing of financial educational assistance shall follow the rates of the current municipal scholarship as stipulated in the existing scholarship ordinance.

The number of recipients may be increased subject to availability of funds.

Section 5. Selection of Beneficiaries - The Office of the Mayor or the department/s designated by the Local Chief Executive as selection committee in coordination with the Youth Development Office, shall present to the Mayor the list of qualified beneficiaries equally divided among the classifications as stated in Section 4 of this Ordinance.

5.1 The final list of recipients under this ordinance shall be duly certified by the Municipal Mayor and forwarded to the Youth Development Office to be included in the official list of the scholars of the Municipality of Taytay.

Section 6. Validity of Scholarship - The financial educational assistance under this Ordinance shall only be valid for the current academic year. A new list of eligible recipients shall be generated annually.

Section 7. Funding - The annual source of funds for the Educational Assistance under this Ordinance shall be from the same funding as the current Scholarship Program of this Municipality.

Section 8. Separability Clause - If any part of this Ordinance is declared not valid, unconstitutional or unlawful, such declaration shall not affect or impair the remaining provisions, sections or parts thereof, which shall remain or continue to be in full force and effect.

Section 9. Effectivity Clause - This Ordinance shall take effect fifteen (15) days after its posting in conspicuous places and in the local bulletin board.
