**AN ORDINANCE CONVERTING AND RENAMING MANUEL I. SANTOS
MEMORIAL NATIONAL HIGH SCHOOL TO MANUEL I. SANTOS
INTEGRATED SCHOOL**

WHEREAS, Section 1, Article XVI of the Philippine Constitution provides that “The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all”;

WHEREAS, the Manuel I. Santos Memorial National High School (MISMNHS), established on June 13, 2006 in Barangay San Juan, Taytay, Rizal, has overall total of 5,753 enrollees varying from Grade 7 to Grade 11;

WHEREAS, the MISMNHS is implementing this academic year the Senior High School Program along with its Junior High School Program and it is necessary to formally convert the said institution into an Integrated School;

WHEREAS, the aforementioned school offers Senior High School Tracks namely: Academic Track - Accountancy, Business and Management (ABM) Strand, Science, Technology, Engineering, and Mathematics (STEM) Strand, and Humanities and Social Science (HUMSS) Strand; Sports Track; and Technical-Vocational-Livelihood Track - Home Economics (HE) Strand and Information and Communications Technology (ICT) Strand;

WHEREAS, the 12th Sangguniang Bayan passed Resolution No. 313 s. 2023 entitled, “A Resolution Supporting the Conversion of Manuel I. Santos Memorial National High School into an Integrated School”;

WHEREAS, the Office of the Regional Director of the Department of Education - Region IV-A CALABARZON issued Special Order No. SHS-A.1-05-008, s. 2023 approving the application of Manuel I. Santos Memorial National High School and be renamed as Manuel I. Santos Integrated School;

NOW THEREFORE, BE IT ORDAINED, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, that:

Section 1. Conversion - Manuel I. Santos Memorial National High School, located in San Juan, Taytay, Rizal is hereby converted and renamed under the School Division Office, Taytay Rizal as “Manuel I. Santos Integrated School”.

Section 2. Funding - The Municipal Government of Taytay will continue to provide funds for the operation and maintenance of Manuel I. Santos Integrated School, for at least five (5) years, or until such time that such funds are incorporated in the national budget.


Section 3. Repealing Clause - All Ordinances, rules and regulations or parts thereof, found to be in conflict with, or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Separability Clause - If any part of the provisions of this Ordinance is held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to remain in full force and effect.


Section 5. Effectivity - This Ordinance shall take effect immediately upon its approval.


