WHEREAS, the Sangguniang Bayan of Taytay, Rizal has enacted Ordinance No. 632 (previously No. 8), Series of 2019 amending Section 1 of Ordinance No. 27; Series of 2003 which originally amended Ordinance No. 4, 1996, providing for the Traffic Regulation of the Municipality of Taytay, Rizal;

WHEREAS, there has been a significant advancement in technology systems used for the processing and enforcement of traffic violations that greatly improves the efficiency, accuracy, and transparency of traffic violation processing and enforcement, and are in line with the objectives of Republic Act ("R.A.") No. 10930, otherwise known as the "*Land Transportation and Traffic Code*";

WHEREAS, the above mentioned Ordinance requires updating to reflect these technological developments, particularly in collecting local violation records to the Land Transportation Office ("LTO") system to ensure that all traffic violations are properly recorded, monitored, and enforced in a consistent and streamlined manner;

WHEREAS, it is necessary to amend the existing Ordinance to incorporate provisions that address these advancements in line with R.A. No. 10930, thereby modernizing the local traffic violation system in the Municipality of Taytay, Rizal;

NOW THEREFORE, BE IT ORDAINED, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, that:

**Section 1.** A new Section 2 of Sangguniang Bayan Ordinance No. 632, Series of 2019, is hereby inserted to read as follow:

**SECTION 2. Inclusion of Technology-Related Fees in Penalties**

In determining the penalties for traffic violations as outlined in the preceding section, fines and fees imposed on violators may include a portion that accounts

for the costs associated with the development, management, and maintenance of the technology systems and electronic devices used to process and enforce traffic violations in the Municipality of Taytay, Rizal.

**Section 2.** All Sections following the new Section 2 shall be renumbered accordingly. Specifically, Section 2 through Section 4 of the subject Ordinance shall be moved to Section 3 to Section 5, respectively.


**Section 3. Separability Clause** - If for any reason, any section or provision of this Ordinance shall be declared to be unconstitutional or invalid by competent authority, such declaration shall not affect or impair the other sections or provisions not affected thereby.

**Section 4. Repealing Clause** - All ordinances, rules and regulations, or part thereof, in conflict with, or inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.


**Section 5. Effectivity Clause** - This Ordinance shall take effect immediately upon approval thereof.
