**AN ORDINANCE CREATING THE TAYTAY MUNICIPAL HIV AND AIDS COUNCIL, DEFINING ITS COMPOSITION, FUNCTIONS, AND PROVIDING FUNDS THEREFOR**

WHEREAS, the 1987 Philippine Constitution declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, under Republic Act No. 11166, or the Philippine HIV and AIDS Policy Act of 2018, all local government units (LGUs) are mandated to institutionalize local mechanisms to respond to the HIV and AIDS situation;

WHEREAS, since April 2025 and continuing, the patient has been receiving continuous ART; 763 out of 6,338 patients are from Taytay;

WHEREAS, Taytay, Rizal, being a growing urban municipality, recognizes the importance of a coordinated, multi-sectoral approach in addressing HIV and AIDS, especially among vulnerable and key populations;

WHEREAS, the creation of a Municipal HIV and AIDS Council is crucial to implement evidence-based prevention programs, increase awareness, eliminate stigma, and ensure care and support services;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained, by the 13<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

**Section 1. Title** - This Ordinance shall be known as the “Taytay Municipal HIV and AIDS Council Ordinance”.

**Section 2. Creation of the Council** - There is hereby created the Taytay Municipal HIV and AIDS Council (TMHAC) to serve as the primary policymaking, planning, coordinating, and advisory body on HIV and AIDS prevention and control in the municipality.

**Section 3. Composition of the Council** - The Council shall be composed of the following members:

Member Representative from the Department of Education (Taytay District)	Member

Liga ng mga Barangay President	Member
Representative from Civil Society or NGOs working on HIV	Member
Representative from faith-based organizations	Member
Municipal Information Officer	Member
Representative from the Business / Private Sector	Member

The Council may invite resource persons or consultants from DOH, Philippine National AIDS Council (PNAC), and other relevant institutions.

**Section 4. Functions of the Council** - The Taytay Municipal HIV and AIDS Council shall:

1. Formulate and oversee the implementation of the Local HIV and AIDS Strategic Plan;
2. Recommend policies and ordinances related to HIV prevention, testing, treatment, and stigma reduction;
3. Facilitate multi-sectoral collaboration on HIV-related programs and services;
4. Support the establishment of community-based HIV screening, counseling, referral, social hygiene clinics, treatment hubs, & primary care facilities;
5. Promote information, education, and communication (IEC) activities in schools, workplaces, and communities;
6. Monitor and evaluate HIV-related data, activities, and trends within the municipality;
7. Ensure access to HIV testing, antiretroviral treatment (ART), and psychosocial support;
8. Advocate for zero discrimination against persons living with HIV (PLHIV);
9. Develop partnerships with national government agencies, NGOs, and private sector stakeholders;
10. Ensure proper coordination with the Municipal Social Hygiene Clinic in the planning and implementation of the local HIV and AIDS strategic plans; and
11. Perform other functions as may be necessary to carry out its mandate under RA 11166.

**Section 5. Meetings and Quorum** - The Council shall convene at least once every quarter, or as often as necessary. A simple majority of its members shall constitute a quorum.

**Section 6. Secretariat** - The Municipal Health Office (MHO) shall serve as the Secretariat of the Council and provide administrative, logistical, and technical support.

**Section 7. Funding** - An initial amount of at least One Million Pesos (₱ 1,000,000.00) shall be allocated from the Municipal General Fund for the establishment and operationalization of the Council. An additional 10% increase in the annual budget for the annual operation shall be allotted. Thereafter, an annual appropriation shall be included in the Annual Investment Plan and the Municipal Budget. The Council may also seek funding support from national government agencies, international donors, and private sector partners.

**Section 8. Separability Clause** - If any provision of this Ordinance is declared unconstitutional or invalid, the remaining provisions not affected shall continue in full force and effect.




**Section 9. Repealing Clause** - All ordinances, resolutions, executive orders, or rules inconsistent with this Ordinance are hereby repealed or modified accordingly.


**Section 10. Effectivity** - This Ordinance shall take effect fifteen (15) days after its posting in conspicuous public places.
