RESOLUTION NO. 137 series of 2020

A RESOLUTION REQUESTING THE HON. GEORGE RICARDO R. GACULA II, MUNICIPAL MAYOR, FOR THE CONSTRUCTION OF TAYTAY TOURISM INFORMATION CENTER (TTIC) TO BE LOCATED IN ALL TOURIST SPOTS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, Republic Act 7160 also known as the Local Government Code of 1991 (Section 17) provides for LGU's responsibility in basic services and facilities that include tourism development and promotion programs, tourism facilities and other tourist attractions, including the acquisition of equipment, regulation and supervision of business concessions, and security services for such facilities. LGUs, as a corporate entity (Section 15) are also vested corporate powers with full autonomy (Section 22) in propriety functions and management of their economic enterprises. However, the condition that this provision is subject to the limitations provided in this Code and other applicable laws negates the 'full autonomy'. The recent emphasis of the current administration towards the practice of the LGU;



WHEREAS, Taytay Tourism Information Center (TTIC) as a product and service oriented industry, could generate widespread benefits and impacts to the economy and society;

WHEREAS, the direct, upstream, and downstream industries involved in tourism activities have the potential for creating sect oral linkages and economic opportunities in the localities;

WHEREAS, it shall provide technical assistance to LGUs in destination development, standard setting and regulatory enforcement; preparation, implementation, and monitoring of local tourism development plans, gathering of statistical data, and enforcement of tourism laws and regulations;

WHEREAS, the TTIC will function as an information center for query and assistance to all visitors in the municipality, a center where vicinity map, leaflets, flyers and other promotion activities are located, and such other functions that will help promote the industry and tourism of the municipality;

WHEREAS, the Taytay Tourism Officer should recommend and identify the tourist spots in the Municipality of Taytay;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby REQUESTS THE HON. GEORGE RICARDO R. GACULA II, MUNICIPAL MAYOR, FOR THE CONSTRUCTION OF TAYTAY TOURISM INFORMATION CENTER (TTIC) TO BE LOCATED IN ALL TOURIST SPOTS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
