## **RESOLUTION NO. 147 series of 2020**

### **A RESOLUTION REQUESTING THE HON. GEORGE RICARDO R. GACULA II, MUNICIPAL MAYOR, TO PROVIDE A TAYTAY TOURISM INFORMATION MOBILE OFFICE IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL**

WHEREAS, Republic Act 7160 also known as the Local Government Code of 1991 (Section 17) provides for LGU's responsibility in basic services and facilities that include tourism development and promotion programs, tourism facilities and other tourist attractions, including the acquisition of equipment, regulation and supervision of business concessions, and security services for such facilities. LGUs, as a corporate entity (Section 15) are also vested corporate powers with full autonomy (Section 22) in proprietary functions and management of their economic enterprises. However, the condition that this provision is subject to the limitations provided in this Code and other applicable laws negates the 'full autonomy'. The recent emphasis of the current administration towards the practice of the LGU;

WHEREAS, the Mobile Office provides a welcoming environment for travelers to congregate, learn about available tourism products and services in the municipality, and make reservations;



WHEREAS, Taytay Tourism Information Mobile Office can provide a space to generate revenue through the sale of merchandise and local handicrafts as well as capture and analyze important traveler information and statistics;

WHEREAS, at the crux of the Taytay Tourism Information Mobile Office concept has its dual mission, mobile tourism information center not only provide information and reservation services to travelers, but can also service local tourism suppliers and the greater community;

WHEREAS, Tourism Information Centers develop these centers and implements training programs with the goal of providing services to both travelers and suppliers, as well as overseeing the daily operations of the center, they are involved with marketing the destination, networking with the local travel trade, planning events, and serving as a liaison with the local community;

WHEREAS, Information Center Development will develop the Taytay Tourism Information Mobile Office into a well presented and accessible physical space to educate visitors about the assets available in the destination, as well as serve as a local hub and meeting place for local residents and stewards;

WHEREAS, Management Training will train Taytay Tourism Information Mobile Office Managers to identify, implement, and monitor commercial opportunities and additional services to raise revenue;

WHEREAS, Local Engagement is a proven ability to engage multiple stakeholders, including public sector, industry representatives, NGOs and communities to work collaboratively to ensure the future of their destination;

WHEREAS, Data Collection is a process for gathering, interpreting, and supplying tourism data;


WHEREAS, the Taytay Tourism Office should identify and recommend the areas where the Taytay Tourism Information Mobile Office will be dispatched;
