A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ACCEPT FOR AND IN BEHALF OF THE MUNICIPALITY OF TAYTAY, RIZAL, A BRAND NEW SHIMADZU DIGITAL X-RAY MACHINE DONATED BY THE ROTARY CLUB INTERNATIONAL, SPEARHEADED BY ROTARY CLUB DISTRICT 3810

WHEREAS, the Rotary Club International (Donor), has donated a Brand New Shimadzu Digital X-ray Machine to the Municipal Government of Taytay, Rizal, thru the Municipal Health Office;

WHEREAS, the donation of this type of hospital equipment would not have been made possible were it not for the effort of Rotary Club District 3810, who tirelessly spearheaded and acted as the facilitator for the said donation;

WHEREAS, the intended beneficiaries of the donated Brand New Shimadzu Digital X-ray Machine shall be those who are admitted as charity patients including our less fortunate residents, as well as students in the paramedical field in terms of educating and training;

WHEREAS, the 11th Sangguniang Bayan had received a request from the Municipal Health Office – Hospital Director, as stated in Communication No. 2002 – 024 to legislate by way of Resolution the acceptance of the donated Brand New Shimadzu Digital X-ray Machine;

WHEREAS, the donated Brand New Shimadzu Digital X-ray Machine has a warranty of two years, thereafter, the repair and maintenance of the same shall be chargeable to the Municipal Government of Taytay, Rizal;

WHEREAS, the liberality of the donor must be reciprocated by the Sangguniang Bayan by way of expressing its utmost appreciation and gratitude for the donation of such hospital equipment which certainly would be beneficial to the inhabitants of this Municipality;


