WHEREAS, TRUPA expresses its support for the Skyway Project but wishes for it to be realigned to Highway 2000 located in Barangay San Juan where it will affect less families;

WHEREAS, the 11th Sangguniang Bayan is dedicated to protecting the welfare of its constituents;


